## CHAPTER 1

### HISTORIC *WE-THE-PEOPLE* NATIONAL COMMON LAW GRAND JURY

#### Feds Ordered To Show Cause Why War And Emergency Powers by Rick Martin 6/7/95

On Friday, June 2, 1995, citizens from around the nation arrived in Wichita, Kansas in anticipation of the weekend. Many gathered in private, small meetings to caucus over various national, political, and historical issues affecting what seem to be ever-diminishing freedoms and loss of constitutional rights. Tension was in the air.

Local law enforcement was, after Oklahoma, understandably concerned that there may be trouble at the Wichita Century II Convention Center. The National Common Law Grand Jury was scheduled to convene on June 3-4 at Century II and, frankly, no one knew exactly what to expect. Security was high. There were meetings with local law enforcement by Grand Jury coordinators to assure them that what was to follow would be a “peaceful assembly”. At the conclusion of the meeting, law enforcement officials were more than a little surprised and impressed at how lawful, peaceful, mature and responsible the meeting had actually been. There were no incidents. The people gathered at this assembly were there to conduct court in an orderly fashion.

The National Common Law Grand Jury was called as a direct result of a court order issued from the Common Law Court in York, Nebraska. The coordinators of the event were merely complying with the Common Law Court’s mandate.

The constitutional authority for a National Common Law Grand Jury is granted under *Articles III and V* of the *Constitution of the United States of America*.

Prior to the convening of the National Common Law Grand Jury in Wichita, during the month of May, the following announcement was faxed throughout the country. It reads, [quoting:]

#### NATIONAL COMMON LAW GRAND JURY

**To hear the facts of the federal government’s use of emergency power and executive agreements to suspend the *Constitution* and rule by statute in all cases whatsoever.**

#### COMPLAINT

**June 3 and 4, 1995**  
**Wichita, Kansas**

People in and for the United States of America ex rel. hereby declare that there has been a gross usurpation of our national *Constitution* and *Bill of Rights*, under pretense of a continuing crisis of War and Emergency conditions that have existed since the Civil War and continue to exist in times of peace to the present time.

Senate Report 93-549 says, “Since March, 1933, the United States has been in a declared state of National Emergency.” Title 12 U.S.C. 95(b) says that every order issued by the President since March 4, 1933, or any order issued in the future is automatically approved and confirmed. These powers being conferred under the Authority of the Act of October 6, 1917, as amended March 9, 1933, are strictly a War Power. (See *Stoehr vs. Wallace*.)

This vast range of powers, taken together, confers enough authority to rule the country without reference to normal constitutional process.

Wherefore, the People in and for the United States of America hereby demand that the President (Bill Clinton) and the Attorney General (Janet Reno), show cause within 60 days why these unlawful powers being perpetrated against the American people should not be terminated, and if they should fail to show cause, then our court with Original Jurisdiction is to issue a Declaratory Judgement in favor of the American People, and any and all remedy it finds proper, against the above named defendant(s). [End quoting.]

The following press-release was issued by Dr. Eugene Schroeder on Saturday, June 3, [quoting:]

WICHITA—A National Common Law Grand Jury is meeting in Wichita, Kansas June 3 and 4. Delegates from each state present are sitting on the jury, hearing evidence and examining more than 100 documents concerning the executive office’s use of war and emergency powers to rule the country for the last 62 years.

Senate Report 93-549 says “Under the powers delegated by these statutes, the President may: seize property; organize and control the means of production; seize commodities; assign military forces abroad, institute martial law; seize and control all transportation and communication; regulate the operation of private enterprise; restrict travel; and, in a plethora of particular ways, control the lives of all American citizens.”

Reuters wire service released a story June 2 that the House is considering giving the President even more sweeping war powers. The action under debate would remove the negligible reporting requirements the President now has to the Congress when he involves U.S. troops in foreign fighting.

“The war and emergency powers wielded by the President and his agencies cut much deeper than sending U.S. troops to fight foreign wars,” said Dr. Eugene Schroeder, author of *Constitution: Fact or Fiction*, and *War and Emergency Powers*, two extensively researched books that sparked the Common Law Grand Jury. “The President and his agencies have the power to, and do, control and license every transaction among U.S. citizens.”

Senate Report 93-549, done in 1973, also says, “Since March 9, 1933, the United States has been in a state of declared national emergency. A majority of the people of the United States have lived all their lives



under emergency rule. For 40 years, freedoms and governmental procedures guaranteed by the *Constitution* have, in varying degrees, been abridged by laws brought into force by states of National Emergency. In the United States, actions taken by government in times of great crisis have...in important ways shaped the present phenomenon of a permanent state of National Emergency.”

It goes on to say, “These hundreds of statutes delegate to the President extraordinary powers, ordinarily exercised by Congress, which affect the lives of American citizens in a host of all-encompassing manners. This vast range of powers, taken together, confer enough authority to rule this country without relevance to normal constitutional process.”

“We are not anti-government,” Schroeder said, “but we do want a government that obeys the *Constitution*. The *Constitution* was the shackles our forefathers placed on the federal government. They reserved all rights to the people and states which were not specifically given to the federal government. Our government has been living outside those bounds for 62 years.”

If the National Common Law Grand Jury determines that the facts show that the federal government is operating outside the *Constitution*, they may ask President Clinton and the federal government to show cause why they continue to operate by War and Emergency Rule. A Summary Judgement could be issued if no response is forthcoming within 60 days. [End quoting.]

Saturday morning, June 3, the Century II Convention Center received approximately 400 concerned citizens from all walks of life, representing 32 of the 50 states. The auditorium floor looked like a Republican Convention with signs on long sticks identifying each state. Those in attendance were asked to assemble with their home state.

Pastor Nichols opened the assembly with a prayer. This was followed by the *Pledge of Allegiance*. One of the organizers of the meeting was Walt Meyers [Executive Director of the Constitutionals Networking Center], who then took the stage for some administrative remarks. He introduced several others involved in the coordination of the gathering. Ed Petrowski then made some additional administrative comments.

The entire court proceeding was videotaped, which constitutes the legal and lawful record.

The stated objective of the National Common Law Grand Jury was to arrive at Facts and Conclusions at Law concerning the status of War and Emergency Powers.

Dave Schecter asked each state to caucus and choose ONE delegate to sit on the jury. The decision process for each state was up to that state. After a relatively brief period of time, delegates to the jury, and their alternates, had been selected.

The beginning of the proceeding was somewhat difficult, disjointed, and tense. There were, after all, some very strong personalities and independent thinkers present. And there were many agendas, stated and private.

There was difficulty in seating the jury. The issue was raised, strongly, that women should not be allowed to sit on a Common Law Grand Jury. Others felt that under the Rule of Necessity women should be

allowed. After some heated discussion, coordinator, Dr. Eugene Schroeder, in a welcome stroke of sanity, took the stage and said something to the effect of, “My God, we live in a modern age. I, for one, will not stand in the way of women sitting on this jury.” To which there was general, but by no means total, applause and the jury was seated.

Dr. Ron Carlson from Honolulu, Hawaii made the statement, “*We-the-People* of the several states are impaneling this jury.”

Richard Perkins made a motion that the jury convene. The motion was seconded and passed. The jury then took their seats at tables set up along the front of the auditorium stage.

The next order of business for the jury was selection of a Jury Foreman, selection of a Court Clerk, and the swearing in of the Jury, Foreman, and Bailiff.

Dave Schecter then asked those assembled that Sally Freck be accepted in the position of Clerk of the Court. There was an objection, the stated reason being that the delegates should be given a choice. Nominations were made and Candace Turner was selected as Court Clerk by secret ballot.

After much discussion among themselves, Darryl Freck was selected as Jury Foreman.

Greg Paulson was appointed Bailiff.

It became clear that there was a need for a Chairman, or presiding spokesman. Gene Dixon, Director of the Constitutional Law Center took the stage, spoke briefly to the jury and added wisdom and experience to the proceeding. Discussion followed and Mr. Dixon was selected to be the person presiding over the jury—at the will of the jury.

A quorum was declared.

The Jury, Foreman, and Bailiff were all sworn in—actually the term used was “attest”, not “swear”.

The Jury was then ready to hear witnesses. Additionally, all witnesses were properly sworn-in prior to testimony.

The first witness to speak was Pam Beasley. Pam’s testimony was obviously going to cover a very wide series of topics seemingly unrelated to War Powers. Gene Dixon stepped forward and stopped her testimony. Dixon then asked clarification from the jury as to the extent of the evidence they were to hear and accept into evidence, which was to be fairly well confined to War and Emergency Powers. Mrs. Beasley was dismissed without testifying.

Dr. Schroeder then took to the stage to ask the jury’s indulgence by hearing the first three speakers who would present evidence covering a wide scope of topics, thus adding to a “big-picture” understanding of our nation’s current situation. It was then agreed to hear such testimony and accept such evidence.

Senator Don Rogers from Kern County, California then spoke of many federal mandates which usurp

state's rights. He spoke of the Clean Water Act, the Clean Air Act, the Endangered Species Act—and used as an analogy of government out of control the Kern County farmer, who was thrown in jail and fined heavily for killing some kangaroo rats with his tractor.

Rogers went on to remind all present that the *Bill of Rights* does not confer rights to the people, but rather it restricts government.

The next witness was Byron Dale, expert on money and fractional banking. Mr. Dale entered evidence into the record about the Federal Reserve Act of 1913, including Eustace Mullins' book *Secrets of the Federal Reserve*; the issuance of currency by the Federal Reserve, including the identity of the 12 families who own the Federal Reserve; information concerning a "gold standard"; and related financial matters. Mr. Dale said that with the passage of the National Currency Act of the 1860s, the laws of destruction came into play. The War Powers Act, according to Dale, was passed to protect banks who rob our country through fractional banking—or what he terms "theft by deception".

Lowell Becraft was not able to attend the hearing, so Ed Petrowski read a statement into the record which was written by Mr. Becraft concerning the subject of Treaties. According to this statement, Treaties have been used by the government to accomplish what War and Emergency Powers hadn't, thereby also subverting the *Constitution*.

It was stated to the jury that Emergency Powers have never terminated, but merely been codified.

The Gold Reserve Act of 1934 was also discussed.

A "working paper" was entered into evidence for the jury to consider. This working paper concerned possible "findings" as they relate to War and Emergency Powers.

Toward the end of the first day, the jury agreed to then hear what the witness Pam Beasley had to say. Pam took the stage and spoke for approximately an hour, entering a comprehensive range of documentation into the court record. Her testimony covered a full spectrum of legislative issues over many years which have resulted in our current national situation.

State Senator Don Rogers then took the stage to offer a summary of information to the jury. At the conclusion of Mr. Roger's remarks, the assembly was closed for the day. The jury was asked to enter into deliberations.

On Sunday, June 5, the jury met in private session. Throughout the day in the main auditorium, a variety of speakers took the stage. By far the most visible, vocal, (and often frustrating to listeners), speaker on stage all day was Walt Meyers.

Other speakers included, again, Senator Don Rogers who shared excellent "sample legislation" with delegates to take back home to their respective states. Senator Rogers is also on the Executive Committee of the Constitutional Networking Center, the organization preparing the sample resolutions. .

The sample legislation included:

(1) A legal document by the States directing their Agent, the Federal Government of the United States to correct our mathematically unsound monetary policy and to terminate operation of the United States under Emergency Powers.

(2) The purpose of this resolution is to seek correction of our nation's mathematically flawed monetary policy and reinstatement of the *Constitution* as the Supreme Law of our land. [95.1]

(3) A legal document from the States to the Agent requiring the removal of all foreign military forces from the United States.

(4) A legal document from the States directing their Agent to repeal an unconstitutional act known as the *1994 Crime Bill*.

(5) A formal instruction by States who, as principals to the *Constitution*, are directing their federal Agent to refrain from attempting to formally abolish, or in any way permanently render the *Constitution of the United States* null and void.

(6) The purpose of this resolution is to foster the establishment of a Commission to analyze constitutional amendments for their authenticity and intent.

(7) The purpose of this resolution is to acknowledge that the State delegations participating in the National Common Law Assembly [95.1] find there is a need for an informal National conference of constitutionally committed state legislators who sincerely desire that the pledge made by our nations 30 Republican Governors "to restore to the States and the people the prerogatives and freedoms guaranteed to them under the *Constitution*" becomes reality and who recognize the value of the *Constitution's* 10th Amendment as a tool for doing so.

(8) The purpose of this resolution is to initiate a lawful and formal process for insuring our nation's laws designed to protect our *Constitution* are justly and equitably applied.

(9) The purpose of this resolution is to promote action to have a formal Grand Jury determine the lawfulness of fractional reserve banking and whether or not this practice aids and abets, or is directly responsible for, theft by deception.

(10) The purpose of this resolution is to formally comply with the requirement of Title 18, Chapter 115, Section 2382, Misprision of Treason.

(11) This resolution is to convey the findings of the National Common Law Assembly [95.1] on the remedies offered by our nation's Republican Governors for their complaints cited in the Williamsburg Resolve. [End sample legislation.]

The resolutions listed were examples and were not debated or adopted by the National Common Law Assembly. The documents were entirely separate from the National Common Law Jury.

Joseph Gold, Chairman of the Christian Heritage Party then spoke on a variety of constitutionally related

issues.

Charles Collins, Republican candidate for President, then spoke before those assembled. He said that he is the dark horse candidate referred to by Rush Limbaugh. He also said he will bypass the controlled media altogether with a system of faxes and computer bulletin boards.

In a series of statements, Collins said, “Reputation is what you earn in the daylight. Character is what you are in the dark.”

Collins often referred to those currently in political office as “people who have been educated beyond their mentality.”

Collins spoke of getting rid of the IRS, BATF, OSHA, EEOC, and the Federal Reserve. He asked for a 5% capped sales tax. He called for a return to the Grand Jury system and asked that we “get back to sensibility and sense in our country.” He went on to speak of the gold standard, a new currency, getting rid of Big Brother and rid of the computers which house all the individual records on people. He even went so far as to speak of knocking out the satellites which track people. He assured those assembled that “we know a good idea when we see it.” He spoke of removing property taxes, obtaining debt-free money and getting government out of the farming business. [*Editor’s note: While we here at CONTACT are not “endorsing” any candidate for President at the moment, Mr. Collins has written a speech which is such a wonderfully cogent historical statement about the Federal Reserve and how it has been draining our country of prosperity that we’ve elected to include it at the close of this series of articles.*]

Joseph Stumph, Chairman of the Committee of 50 States and author of *The Ultimatum Resolution*, then took the stage to discuss the *Ultimatum Resolution* and the Conference of States. “What are our alternatives? What are our remedies?” Stumph pleaded with those present. He assured those assembled that he was not advocating secession, but rather put it forth as a possible future option which would be better than accepting the New World Order or entering into another civil war. While Stumph was opposed to a constitutional convention, he was in favor of the states meeting to enter into fruitful discussion of key issues.

Senator Don Rogers addressed the assembly once again, referring back to the *Magna Carta* and King John, saying that they had environmental legislation back then—if you shot a deer in the forest it was an automatic 1 year and 1 day in jail. He again reminded those present that the *Bill of Rights* are not rights but rather what the government cannot do. Several other speakers also had comments to make.

Sunday afternoon, June 4, Candace Turner, Court Clerk, resigned for personal reasons.

Were there obvious difficulties throughout the weekend? Yes. Were there disagreements and heated differences throughout the sessions? Of course, to be expected. In the final analysis, it really doesn’t matter. What does matter is the miracle which did take place—a National Common Law Grand Jury comprised of *We-The-People* from 32 states attaining a quorum and arriving at a decision—a Finding at Law.

A Juror’s Report, written by Dr. Ron Carlson of *The Phoenix Project/Committee of 50 States*, has just

been received by *CONTACT*. We are including it at the conclusion of this article.

Sunday afternoon, at about 4:00 p.m., the National Common Law Grand Jury was seated, once again, before the General Assembly. The Foreman announced that the jury had reached a decision and released the following news release, [quoting:]

### LET FREEDOM RING

Let the record show:

Your National Common Law Grand Jury having convened in Wichita, Kansas on June 3, 1995, heard testimony and reviewed evidence to require the Government to show JUST CAUSE within sixty (60) days why it has operated outside the clear bounds of the *Constitution* of these united states of America since March 9, 1933 under the pretense of a national emergency.

A war measure known as the *Trading With The Enemy Act* of October 6, 1917 was used to usurp the constitutionally secured rights of the people. Section 5(b) of this Act was amended to include almost all domestic transactions placing the American people in the same class with alien enemies, thus allowing the federal government to rule by statute in all cases whatsoever.

That evening at 8:15 p.m. central time, in closed deliberations, the juror from New York made a motion to the jury at large for a yes or no vote on the above question: "Do we have sufficient evidence to require the government to show just cause, etc." It was also understood more evidence could be considered and added later. The motion was seconded and passed unanimously. We do have sufficient evidence. The rest of the evening centered around the final wording of the Findings of Fact of the National Common Law Grand Jury pending their final approval the next day.

And so it begins...on this historic day June 4, 1995. The National Common Law Grand Jury proclaimed their Findings of Fact to their country and the world and recorded their proceedings on videotape for posterity.

### COMMENTARY:

So let the word go forth to friend and foe alike that a new generation of Americans has picked up the torch of liberty to proclaim "LET FREEDOM RING. LET FREEDOM RING." [End quoting.]

The General Assembly and National Common Law Grand Jury concluded by all present joining hands in prayer. Following prayer, the entire Assembly sang *God Bless America*.

National Common Law Grand Jury on June 3rd and 4th of this year, with 32 of 50 states represented, examined evidence presented and focused upon the Banking Act of March 9, 1933 and its relationship to an undeclared, yet ongoing, everpresent state of emergency. The presenters of evidence were: (1) Byron Dale, educator and monetary expert, demonstrating that our current debit monetary system, rather than a credit monetary system (constitutional form), was finalized by the March 9, 1933 Banking Act; (2) Lowell Beecraft, attorney, presented "Treaties: A Source for Federal Municipal Power", clearly placing treaties, such as the Migratory Bird Treaty Act of 1913, in a superior position to the *Constitution*, as cited by *Fuji V. State*, CV 17309. April 24, 1950 (California), affirming that treaties made pursuant to the March 9, 1933 Banking Act accelerated the usurpation of common law and constitutional authority; (3) Dr. Gene Schroeder recited a chronology which, in effect, placed the American people in direct opposition as enemy to the U.S. Government, beginning with the War Powers Act of 1917 and ending with current law 12 USC 95(b), which affirms and confirms the Banking Act of 1933; and (4) Pam Beasley, who related the "Methods of Management" that have been employed via such initiatives as "Global 2000" and others (including 41 related documents and videos) establishing a "de facto global governance" by Khazarian-Zionist-Mishpucka-controlled United Nations, as a direct result of events and legislation derived from the so-called "emergency" created by the Banking Act of March 9, 1933. Deliberations took place for two days by 32 state jurors and their alternates, resulting in a "Findings of Fact and Conclusions of Law, Order to Show Cause", refuting the government's unexamined assertion that for the past sixty-two years we have operated as a constitutional republic. Clearly to the jury, evidence suggested that we have rather operated as a municipal corporation, or, in its extreme form, a fascist state. The Petition, Order to Show Cause, will be presented to the President of the United States of America, Attorney General Reno, Speaker of the House of Representatives, the President of the Senate, the governors of the fifty states, and other pertinent parties. By 5:00 p.m. Sunday evening, June 4, 1995, the document to be so presented was signed and attested to by 32 common law jurors in Sedgewick County, Kansas, for the several states of America. The U.S. Government will have sixty days in which they may respond to the Order to Show Cause or face more definitive action by the National Common Law Grand Jury. We thank, from the heart of our hearts, Creator God, our Father-God, for allowing us to be present during this National Common Law Assembly, and for the results guided by His hand that may now be known as the "new shot heard 'round the world".

**BY 16 VOTES,**

**HOUSE KEEPS WAR POWERS RESOLUTION**  
**ON THE BOOKS**

With Bosnia overshadowing the debate, the House Wednesday defeated a GOP-led effort to repeal the controversial 1973 War Powers Resolution.

In a 217-201 vote, the House voted to preserve the largely symbolic Vietnam-era requirement that a president notify Congress within 48 hours of putting U.S. troops in harm's way.

Under the law, Congress must OK the military deployment within 60 days for troops to stay, but presidents have ignored the statute and federal courts have refused to enforce it.

House Judiciary Committee Chairman Henry Hyde, R-Ill. who sponsored the defeated amendment, called the War Powers Resolution a "wet noodle, a useless anachronism."

Supporters of repeal also argued that a president can't wage war without having it funded by Congress anyway. "We control the purse strings," Hyde said. "Without the appropriations, they can't get a drink of water."

Votes crossed party lines, but minority Democrats won a rare floor victory by arguing that Congress should maintain its constitutional power to approve a president's decision to send troops off to war.

**S.5, THE PEACE POWERS ACT OF 1995**

"I would think the last few days of Bosnia (is) the greatest reason for why we should not do this right now," said Rep. Patricia Schroeder, D-Colo.

"We are on the brink of war," agreed Rep. Toby Roth, R-Wisc., citing "the deepening crisis in Bosnia. In months, weeks or even days, we may be grateful we have [it] on the books."

Supporters argued the law forced President Bush to hold an important congressional debate before sending troops to the 1991 Persian Gulf War.

Rep. Lee Hamilton, D-Ind., who led the effort to defeat the amendment, exhorted his colleagues not to "send a signal to the American people we have abdicated our power and give it to the president carte blanche." [End quoting.]

**ON FEDERAL RESERVE CANCELS**

My Fellow Americans:

In Green Bay, Wisconsin, at the Midwestern gathering of Republicans in May 1995, I had planned to end my speech with an explanation of the historical significance of the way three of our great presidents had handled the devastating, blood-sucking scourge of a central banking system. It is critical to our survival as a great nation that I get his message out to every citizen across America. It is worthy, I think, of your intense consideration.

Our forefathers came to this land to seek freedom; freedom from oppression, freedom from direct taxes, freedom from property taxes that could lead to painful loss of that property if sold for unpaid taxes; freedom to keep property that was not subject to taxes, so that they could own lands, build homes, and keep that property in the family for generations, with allodial right of ownership once the property was paid for.

Our forefathers established a Constitutional Republic for us that recognized the Sovereign power of the citizen. This power was from God; a gift that was not given by any government. But rather, man gave to the government only certain delegated authority that the citizens felt could better be handled by a central, federal government for the people, at their direction, and under their control.

One of those authorities was to the legislative body to coin money, and set the value thereof.

There was a move made by a group of international bankers to establish a national bank during President Jackson's term. He angrily denounced them, vowed that there would be no national bank to prey upon the people, and threw them out of Washington. There were two attempts made on his life, and some historians have placed the blame squarely upon the disgruntled bankers. Jackson said he would pay no interest to bankers on our national currency.

During the Civil War, President Lincoln had need of emergency money to pay for the war. Foreign bankers offered to lend him the money at high interest, but he chose to create the first printed money in the U.S.A. Because of their color, they were called "greenbacks". The smaller denominations were called "shin plasters". The U.S. Treasury has a supply of this money still, but it is not circulated. It is still lawful money. It was not created with debt, and no interest was ever paid on this money. President Lincoln was quoted as saying about the international bankers: "The money power preys upon the nation in time of peace, and conspires against it in times of adversity. It is more despotic than monarchy, more insolvent than autocracy, more selfish than bureaucracy. It denounces, as public enemies, all who question its methods or throw light upon its crimes."

"I have two great enemies, the Southern Army in front of me, and the financial institutions in the rear. Of the two, the one in my rear is my greatest foe."

President John F. Kennedy took office with many things on his agenda that were considered liberal. He expressed real concern for our country, however, in his inaugural address. By 1962, he determined to change the monetary system of the United States. Without any fanfare or announcement, he issued an Executive Order that instructed the U.S. Treasury to print our own money, which he called "United States Notes", and which would not be tied to the Federal Reserve System at all. He bypassed the Fed to print

debt-free, interest-free money. This was the same bold, historical move made by President Lincoln one hundred years before. He announced that he had determined a method by which he would return America to her People.

He obviously should have told everyone in the country that he was by-passing the Federal Reserve System, and would no longer allow our own U.S. Currency to be loaned into circulation by a corrupt system owned by foreign bankers, where our people were required to pay interest on all U.S. money, created out of “thin-air” by the Fed, not by honest labor, but by an illegal cartel of foreign bankers.

His failure to tell the people what he was doing, and why it was essential to the United States to keep from paying immoral, unconstitutional interest on their own money printed by our own Treasury, was the probable cause of his assassination in November, 1963.

Immediately following President Kennedy’s death, a directive by President Johnson stopped the printing of the United States Notes. President Johnson returned to the policy of borrowing all money into circulation from the clandestine Federal Reserve System.

The Federal Reserve System is no part of our U.S. Treasury, or Federal Government. It is a private corporation chartered by Congress in 1913. It was created by an unholy alliance between a private banking cartel, and the Congress who should have all the legal and Constitutional oversight of the mechanics of coining and printing all U.S. Money. The Federal Reserve System has never been Federal. It has never had any Reserve. It has never had any operative System. The (12) regional Federal Reserve Banks are a sham and a fraud. The directors have no other authority than to set the interest rates charged to banks in their district, but their every action is subject to review and reversal by the New York Federal Reserve Bank and, the head of the F.R.S., Alan Greenspan.

The Federal Reserve is so patently illegal and immoral, and so secretive and clandestine that the only way it can survive is to stay a mystery to the American people. It is so rotten that Henry Ford was prompted to say, “If the American people understood what our monetary system and the Federal Reserve System were doing daily to hurt them, I predict there would be a revolution before morning.”

The “Fed” is corrupt and so insidious by nature that you must realize it is a license to steal. It is in no way fair. All of us here assembled could demand that the Fed be thrown out, and that we become the “New Citizens Federal Reserve System”. They have had it long enough. We could, like the “Fed”, create all the money we needed “out of thin-air”, and lend it to the Government at interest. They have no reserves, so we would not need any reserves. They do not have any, real, nation-wide system of banks. We would not need even to pretend to create such a farce. We would just have one central office bank, such as the Federal Reserve Bank of New York, where all the power resides. You and I, as citizen bankers, could perform everything the Fed does without any loss of motion or confidence in the banking system. The power brokers would change, and the flow of all the money and profits from the banking business of the American people would change. But this change would still be as illegal and immoral, and unconstitutional as the current Federal Reserve System. Therefore, the Federal Reserve System must be abolished to correct our failing monetary system.

The Internal Revenue Service is another private corporation that is abusive and oppressive, and must be

abolished! How do you know it is a private collection agency for the Federal Reserve System? Just read its charter, or better yet, notice on all IRS correspondence there is postage paid, not marked as “Official U.S. Business” which would require no postage.

The Federal Reserve System has drained trillions of dollars from the U.S. economy and the American People. As your next President, I must assure you that I would follow the precedent already set by President Jackson, President Lincoln, and President Kennedy. The American people, and I, together will act in concert to abolish the Federal Reserve System, and take over its assets, both here and abroad. We would also abolish the income tax, the Internal Revenue Service, and install a 5% capped Federal Sales Tax to be collected by the dealers in each state. There would be no Federal Bureaucracy needed for the collection of the Federal Sales Tax.

We are hereby notifying every person in the United States about our intention to dismantle the playhouse of the Federal Reserve System, and why. Every citizen must know that the FED is illegal and unconstitutional, according to Art. 1, Section 8. Every citizen must know that every recession and depression in the U.S.A. since 1913, has been caused by the FED manipulating the U.S. money supply, and the rate of interest paid by our government, and the U.S. taxpayers/citizens.

Congress was duped in 1913 into passing the Federal Reserve Act. The Congressional Record reflects the feeling during debates that those who voted for it thought they were breaking up the Wall Street “Money Trust” by creating the 12 “Branch Offices” of the Federal Reserve System. Even casual observation should have shown Congress that the “Fed” was a lie and a sham. If our Congress in 1934, or 1939, or 1995, had the sense and guts to stand up to reality for the American people, there should have been a law introduced in any and every Congress since 1934 to abolish the FED and take it over.

Both the Democrats and the Republicans realized in 1932 that the Federal Reserve had caused the great Depression in 1929. Both parties had in their Platform a plan to abolish the Federal Reserve System that year. The Republicans had the same plank in the Platform in 1936. The idea to abolish the Federal Reserve System is obviously not new. It is, however, overdue.

Today I must ask every citizen/voter to listen, and read, and learn what is eating up all our income taxes, our personal money, and the heart and body of our jobs and economic system. The Federal Reserve System is historically and patently totally responsible for the recessions and depressions in our country. Hard work and ingenuity of the American people are the only things creating real money today. Then the Federal Reserve System siphons off our excess cash flow, and creates an artificial money shortage. The “Great Lie” of all time has been that we must let the FED “lend us some more money into circulation”. This license to steal must be stopped. We will stop it! But you must spread this message across the nation, so that every citizen understands why and how the Federal Reserve System must be abolished, and its assets recovered by the U.S. Treasury.

Only “Knowledge” will set you free! Only universal knowledge of the dangers of the Federal Reserve System and its awesome power over money, politicians, and life and death of those who dare expose them, can allow us to follow the brave footsteps of President Jackson, President Lincoln, and President Kennedy. These great presidents saw what was wrong with borrowing our own national currency from an unconstitutional foreign cartel of bankers, paying them interest on our own currency we printed, and

allowing them to control the amount of money we have in circulation, and the interest rate charged to the government, and to the people. And not one dollar loaned by the FED was created by work, or labor applied to a raw material to make a product to be sold. During all this commotion, running and reporting, the lady reporter kept talking about the UNDERGROUND TUNNELS, which had been blown open. She kept referring to the HUGE UNDERGROUND TUNNELS and there may be people trapped in there. I heard her refer to the UNDERGROUND TUNNELS at least about 6 to 7 times during the period I watched. I'm not quite sure how long that was. Maybe 1 to 2 hours.

After some internal trepidation and excuse-making (especially since I've never called his show—or any call-in program—before), I finally did make the call, "miraculously" got through the usual, chronic busy signals without a wait, and told my story. He cut me off before I could get to the good, confirming stuff you just read above, but at least I was able to query his listening audience to see if anyone had heard the same early news I had. No specific confirmations were forthcoming that I have heard about—so far—but I'm certainly not privy to all that crosses Art's desk, especially faxes and private telephone calls, nor did I religiously listen to the show the rest of that night and the following several evenings to be sure to catch all the on-air incoming chatter that may pertain to my request.*

*One humorous episode DID occur about a half hour after I was on the air: After I spoke, Art quickly played down my story as "(hmmpph!) highly unlikely" since HE listened to a lot of news at the time and HE didn't hear anything like that...blah, blah, blah. ## CHAPTER 3

### FBI INTERVIEWS MICHAEL MAHOLY

June 10, 1995

Dear Rick,

I would like to share an event that has recently taken place here in Yankton. This will prove beyond a shadow of a doubt that, as a result of both the *CONTACT*'s and my efforts, we have been making a lot of progress in obtaining an investigation into allegations surrounding the corrupt law throughout America, especially in the hometown of many of our—let's call them associates—in Arkansas.

On Thursday, June 8, 1995, at 10:30 a.m., I was called to the S.I.S. office here in Yankton and asked if I would speak to the F.B.I.'s Special Investigative officer, who was dispatched from the Sioux Falls, South Dakota office to look into a letter that I had written to the *CONTACT* and which I had also sent to the nation-wide popular T.V. show *Unsolved Mysteries*. The letter of which I speak pertained to the death of the two young boys from the Little Rock area in Saline County, Arkansas. The two boys' names were Kevin Ives and Don Henry. They were found dead on a remote stretch of railroad tracks in this suburban town of Little Rock, Arkansas. The incident was declared to be another suicide—a result of a marijuana-induced sleep, that caused the two boys to fall asleep on the railroad tracks, only to be run over by a fast-moving freight train. This was the conclusion of the state medical examiner, Fanny Maleck—a close friend of the then-governor Bill Clinton.

The story has made national media news broadcasts and has been the topic of much controversy ever since. It has yet to be solved as to who was really involved and why the deaths occurred. There has been a lot of local talk that illegal drug activity at the local, state and even federal levels of government was involved and that a massive campaign was employed to cover the tracks of the murderers.

The F.B.I. agent who had made the two-hour drive to talk with me seemed very friendly, although this could have been a classic case of "good cop/bad cop", but nevertheless, I—being the man I am—granted this man an opportunity to speak his mind. Before allowing him any information, I was assured that I was not in any more trouble of any type; in fact, the agent assured me that I was now a valuable asset to the F.B.I. for the very accurate data I possess which pertains to a lot of events that have taken place in the towns and hills of the "good ol' boy state"—the "Bubba state"—Arkansas.

The agent brought a two-inch F.B.I. case file along with him. Although he would not directly show the file findings to me, he would, on several occasions, look into the file to confirm names, places, and events, assuring me that they matched what information I was supplying. He told me that there has been an intense investigation looking into accusations, made by several people, that foul play was involved, but things, in a case like this, sometimes take years to solve, unless someone like me comes along and gives them the break the investigators need to solve the case. He told me that many, many hours of police work went into the case so far. I replied that this was true—that many hours of **corrupt police planning** was involved in covering up the incident!



He then asked me about some of the people involved, the COBRA UNIT that was made up of state, local, and D.E.A. drug task force officers. He mentioned names like Alan Swint, Jay Campbell, Kirk Lang, and other law officers. He asked about Dan Harmon, who was the state prosecutor of Saline County, and Dan Lasater. He was pretty well informed about the people involved. I made it a point to mention our good ol' buddy, Jim Guy Tucker, who you will find out in the end most likely had a piece of the drug rewards, whether indirectly or not. You can just bet on it that if illegal drugs were involved, which they were, Jim Guy Tucker and the Clinton gang were involved somewhere in the shuffle. The agent's reply to my accusations about Tucker was, "He's got enough problems already!" I said, "Well, if he (Tucker) doesn't like what's happening to him now, I know, for a fact, that he won't like what's coming up!"

The agent asked, "Is that some type of threat?" I replied, "No, that's a promise!" He just sort of chuckled. The agent asked what in the hell was going on in the rural, backwoods state of Arkansas! I replied, "A lot of corruption, self-gain, greed, lust and evilness!" He said that things are changing and the bureau will get to the bottom of all this. I had to be somewhat skeptical, stating that I was sucked into the illegal drug and weapons game by higher-ups, but at the same time, I would not deny my part; I would accept responsibility for my own actions and any judgments I have made in the past, as well as any I make in the future. The agent knew of my past, as many, many hours of investigation were also spent looking into my life. He did admit that there were some holes, some unanswered questions surrounding some of the more covert operations, involvements, but under the circumstances, they, the F.B.I., could understand. Even the agent stated that money is power, that people are greedy, especially a select few. He was very professional and careful not to mention the elite few by name, but I sensed a mutual agreement about the people we spoke of.

The questioning lasted perhaps an hour and a half. Then he questioned another inmate, whose name you already know, but who wants not to be mentioned out of fear for his life, as he must return to Arkansas in just five more months and does not want to become another accidental suicide in the Bubba town! The other inmate confirmed with me after the visit, that the agent was hot on the trail and had a very accurate idea of what took place that night of the deaths. As it turned out, we both were asked if we would consider testifying in a grand jury and, of course, the bottom line was that we would, whether we wanted to or not!

I have no problem with helping the F.B.I. solve this case, as I know the parents of the two boys want this case solved and put to rest and for justice to prevail. From those of you who are reading this information: what I need very badly are the names, addresses—any way I could contact the parents of the young boys. I also would like them to contact me A.S.A.P., as I have a lot of additional information for them and their attorneys. Please help me to help them. We must speak and, if necessary, I will include them on my visitors' list. They must put the boys' deaths to rest, as you or I would only want to do the same.

Again, I predict that major things will soon be taking place in the land of opportunity—Arkansas! As we have recently heard, Jim Guy Tucker has been indicted, which is just the tip of the iceberg. Take it from me, when the courts squeeze you, people in trouble tend to tell on others, especially when the Feds start throwing "time" at you. Tucker, being the sissy he is, the coward, the bigot, the snake [*and those are his GOOD qualities*], the man who condemned our good friend Richard Wayne Snell to death, when he was the only person who could have stopped the execution, will now be in the dragon's seat himself. I personally wish that when they convict Jim Guy Tucker, they would send him to Yankton, so that he could bunk with me. We could talk about old times together, the drugs, the booze, the whores, the money, oh,

and let's not forget our little feathered buddies, the DUCKS! Oh, how I would love to chat with him!

So please print this for the whole world to read and, as things develop, as you know, I, old "Scoop" Maholy, Federal property, inmate #19365-009, will tell the truth, the whole truth, and nothing but the truth, so help me COMMANDER!

On a final note, it's been some time since I mentioned my two bears—Mama Bear and Baby Bear. We are together, though so far away! Good day!

## CHAPTER 4

### SATANISM IN AMERICA

#### PART I: IT CAN'T HAPPEN HERE

*While this subject is repulsive to most, and indeed many deny its very existence, it becomes increasingly urgent to become informed about this practice which has crept into our society at all levels. The Gilmer, Texas story in the preceding issues of CONTACT is but one undeniable example—there are so many others. But what is Satanism and how can one recognize its presence in day-to-day activities?*

*The Church of Satan is a legal church practicing under the right of the 1st Amendment to the Constitution. But there are other aspects to satanic practice which are well hidden from the curious on-looker and these more deviant, vile and violent aspects of the expression of satanic practices in America will be thoroughly explored in this on-going series.*

*So, readers, I must ask your trust and indulgence as you read some unpleasant material in an effort to become better educated on a topic which is dangerous indeed and which, surely, is closer than you realize.*

*As it makes no sense to re-invent the wheel, I will be pulling information from an excellent variety of sources. I would like to acknowledge and thank, right up front, two primary people whose research I will be utilizing—they are, John E. Hunt, Sr. (Jireh Foundation, P. O. Box 224501, Dallas, TX 75222) and Ted L. Gunderson (Ted L. Gunderson & Associates, 2218 Wilshire Blvd., #422, Santa Monica, CA 90403).*

### SATANISM

*In The Cause, Effect, and Spread of Non-Traditional Satanism and Occultism in America, John E. Hunt, Sr. writes, [quoting:]*

Satanism, as with other traditions, has its pure form as well as its diluted or combined forms. The common thread stems from the worship of Satan who is the Biblical and historical antithesis of Jesus Christ, the Christian Messiah. A helpful perspective in evaluating the effects and methodology of Satanism is to compare it with Christianity and to visualize an exact opposite from Christian teachings and Biblical principles. Since Satan is the antithesis of God, then what he does and how he does it will be destructive to God's law and godly (good) behaviors.

Note: To many of us, Satanism, paganism, and the occult seem to be unreal manifestations of overactive Hollywood imaginations. It is not necessary for you to believe in Satan as long as there are those in society who do believe it and worship Satan and control their personal activities accordingly.

Satanism generally does not include the intense ritualization seen in pure paganism. Satanists less often

construct ritual circles to ward off demons and evil spirits because they don't care. Their desire is to have close intercourse with Satan and his demons.

Satanism comes from the root word "sata" an adjective which means "evil". This has been personified as "Satan" or the "evil one" through the ages. Satan's first introduction is through the Biblical account in the *Old Testament Book of Genesis* where he was represented as a serpent who misled Eve and Adam into sinning by eating fruit from the Tree of Life.

We see Satan in three basic groupings today:

1. Adult groups
2. Adult and adolescent groups
3. Adolescent groups

The second group combining adults and adolescents carries with it the most extreme potential for abuse and death of children if they are not related to the adults in the group.

Those in group 3, all adolescents, usually are experimenters with satanic rituals, not sincere, involved, knowledgeable practitioners of pure traditions. However, ignorance of the true implications and some of the ritualized skills does not mean that adolescent Satanism is any less dangerous. As with any other addiction, ever deeper involvement occurs.

Pure Satanism requires intense training, initiation, screening, rituals and rites and an upward mobility within the satanic worship structure.

Satanic rituals have some parallels with pagan rituals. Satanists also locate a site which is isolated to insure privacy. Each satanic worship group has its own grimoire (pronounced GRAY-MORE-AY), which is called the *Book of Shadows*. On the blank pages of this book oaths and names are written in blood. The grimoire is very important evidence about the depth, structure, and activities of any particular satanic group.

Recruitment into active Satanism is a well planned and subtle process which has devastating results. Initial introductions to the subculture of Satanism are prevalent. In fact, they are seen everywhere we turn today. Signs, symbols, and influences of satanic involvement can be observed in modern music, in the dress and activities of adolescent peers through television, MTV, movies, clothing, games, and drug abuse. Since the late seventies a great deal of satanic symbolism has publicly surfaced in wide variety. What one sees everyday he tends to accept more easily.

Although it is easy to stereotype all heavy metal, hard rock musicians as active Satanists, this is probably not true. There are some who do practice satanic worship. Much of the hype seen on album covers and in the movies are Hollywood publicists' attempts to create attention for their products. The effect on impressionable adolescents is that they become conversant with a wide variety of satanic symbolism and terminology and are therefore more easily drawn into active involvement, or at least away from traditional

value systems.

It is interesting to note that Jimmy Page, who is the lead drummer for *Led Zeppelin*, lives in Aleister Crowley's house in England. Such movies as *Rosemary's Baby* and *The Exorcist* stress magic, the occult, and evil phenomenon which foster fear and helplessness in the minds of those who see them.

The term "occult", an adjective, merely means "hidden or secret". The distinction must be made about specific types of activities which we have lumped together under one label. Modern clothing, "T" shirts and jewelry, so popular with the youth of this nation and the world, stress satanic and pagan symbols, representations of horrible specters, and demons. These tie in with the fantasy role playing phenomenon which anesthetizes chronic players to the actual spiritual implications of satanic involvement. There have been numerous cases of death attributable to fantasy role playing games in the United States out of an estimated two million active players. The addictive mentality predisposes some adolescents to seek involvement in spiritual/supernatural manifestations. The heavy emphasis and involvement of today's youth in illicit drugs tends to blur their distinction between reality and fantasy opening the doors of their minds to accept and explore supernatural phenomenon. In effect, they begin to lose touch with what is reality and become very vulnerable to suggestion.

Irresponsible media coverage and sensationalism contribute to the overall attack on the stability of today's youthful minds. In addition, a strong peer acceptance and support makes it almost impossible for those with addictive or dependent personalities to refuse to go along with the group.

Active Satanists use an insidious variety of approaches to entangle new converts ever deeper into Satanism. Young people, as mentioned before, are very prone to involvements. Mike Warnke in his book, *The Satan Seller*, documents the progression which commonly is used to recruit new Satanists. College campuses are a hot-spot for recruitment. Warnke illustrates actual examples where he, as a former alleged Satanic priest, invited young people, starting in on the fringes of drug use, to parties where drugs and free sex were provided. In a back room, those higher in the satanic hierarchy prepared stronger doses of drugs which they offered freely to promising-looking recruits. In the guise of sexual orgies (with drugs and alcohol plentiful) new converts were drawn deeper into dependence on what the Satanist could provide in the way of earthy pleasures. As they gave in to the lusts of their own desires, they were drawn farther into dependency. They developed thirsts for other things also, such as power and money. At each level the newcomers were scrutinized by those initiated into higher levels in the satanic movement and the best prospects were promoted. As the converts were initiated into the ritual meetings of the Satanists they became more and more debased in what they did. In effect, the more detestable the ritual activity the bigger the "spiritual high" the worshippers receive.

The illegal debased acts include, but are not limited to rape, sodomy, ritual mutilations, child abuse/molestations, cannibalism, desecration of Christian sacraments and ritual murder.

The impact upon youthful worshippers has a devastating effect. Impressionable youths who feed on the negative and evil aspects of today's music and rebellious media representations, experience an erosion of the stable beliefs and value systems which give us security. As their insecurity increases they are drawn to some type of peer support. Involvement in the negative and illegal aspects of Satan worship may debase the individual and cause them to be tormented by tremendous feelings of guilt and isolation because they

have been unable to completely shed the traditional values with which they were raised.

Satanism is very destructive to youth and there is much support for suicide among teens (who so quickly run out of perceived alternatives). Occasionally teen peer groups will take blood oaths and make suicide covenants, i.e., so that if one commits suicide they will all do so. Anything which leads the youth of today to the “end of the line”, where they see no alternative but self-imposed death, must be taken seriously. Because of misguided peer loyalty, those who are knowledgeable about suicide pacts often protect their friends from authorities who would seek to prevent their suicide. By not wanting to risk ostracism by the peer group, youths may also protect friends and acquaintances who are involved in Satanism.

Television correspondent Tom Jarrell narrated a *20/20* segment entitled, *The Devil Worshipers*. This documented a situation in Northport, Rhode Island where teenagers were involved in the ritual killing of another human being. In Phoenix, Arizona, officials found the carcasses of over 140 dead dogs and thousands of animal mutilations due to satanic rituals. A situation in Walnut Grove, Alabama involved the discovery of a ritual site complete with symbols and satanic graffiti indicating secret meetings were taking place on a regular basis. Such things as 666, inverted crosses, closed satanic stars or goat head stars, the *all seeing eye*, desecration of churches, references to the “beast” and goat’s head with a pentagram on its forehead are typical satanic symbols.

The Church of Satan, as an established entity, has been officially recognized in California. Its proponent is a man by the name of Anton LaVey who wrote the *Satanic Bible*. He is involved in active worship of Satanism as a church, but denies any involvement in the illegal activities or illicit drugs. There are countless other satanic groups practicing rites and rituals which are very illegal. Although chants and incantations to Satan are not illegal per se, the higher levels of Satan worship involve unequivocal violations of the law. On that basis, official action can be taken against satanic groups and Satan worshippers individually.

A forensic pathologist was allowed to videotape portions of an actual satanic ritual ceremony which involved mutilation of a dead human body. The origin of the body was not represented on the tape. (A coroner viewing the tape said that it appeared that the body was still fairly fresh at the time of the mutilation.) Cannibalism of the heart and a sexual orgy in the blood of the “sacrifice” were documented on the tape.

On the tape of the satanic ceremony various ritual incantations were repeated by the priest and the group of worshippers who were arranged in a circle around the dead body. There was a strong emphasis on worshipping death. At one point the priest cut open the chest cavity of the corpse and tore the heart out, which he passed around the circle, giving each worshipper the opportunity to bite a piece of the heart off and chew it. On the videotape it appeared that the worshippers partaking of this cannibalism were developing physical ecstasy. The ceremony then degenerated as the worshippers discarded their clothing, took blood from the body cavity of the corpse, smeared it over their own bodies and proceeded to have a sexual orgy.

Although not every Satanist group completes ritual human sacrifices, they do partake of a wide variety of abusive sexual activities aimed at destroying innocence, which Satan must truly hate because God of Christianity loves it. The *20/20* segment documented young juveniles less than ten years old, who were drawn into active Satan worship by their adult guardians and who assisted in the ritual slaying of other



young juveniles who were tied to the satanic altar. The children themselves did not have the strength to force the knife into the victim's body far enough to kill. They described it in the interview that they held the knife and an adult's hand assisted in forcing it through the body of the victim.

Generally victims' bodies are effectively disposed of, usually by cremation. The level of secrecy and commitment to Satan and the spiritual powers of darkness almost guarantee that the participants do not talk about their activities. The problem is that we have many stories without identifiable victims. There is a need for a growing awareness, in society, about the potentialities of satanic involvement. Occasionally, ritual murderers and serial murderers who have been linked to satanic worship are apprehended and prosecuted, but too often their stories are viewed as exceptions merely seen as a horrifying spectacle instead of a warning of growing movement. Most normal people would rather not think about the horrors involved; they cannot easily accept the weight of the facts and their implications.

More and more frequently children and adolescents are becoming the victims of ritual molestations and/or sacrifice. This is primarily because the more innocent and virginal the victim, the more Satan, supposedly, likes it and, therefore, more power is imbued to the Satanist. Children are easier to recruit as potential victims than adults. It is easier for Satanists to kidnap them at a young age and move them from place to place.

Adolescents become very mobile in this society. They often run or are displaced by a disintegrating family structure. They are easily drawn into the victim role because no one with responsibility has an awareness of where they are or what they are doing. [End quoting from John Hunt's manuscript.]

In another manuscript received by *CONTACT* from Ted Gunderson, which was researched over many, many years concerning the subject of Satanism and titled *Corruption: The Satanic Cult Drug Network And Missing Children, Vol. I & II*, former FBI Agent Ted Gunderson writes, [quoting:]

We have information that police officers, prosecutors, morticians, ministers, teachers, doctors, lawyers and others of all ages, in all walks of life, are practicing Satanists. Many of these individuals lead double lives. To some they appear as leading citizens of the community, and to their fellow cult members, they are dedicated evil worshippers. We have been told that a superintendent of schools in California is a Satanist. Michael Acquino, head of the Church of Set in San Francisco was a lieutenant colonel in the Army Reserves in charge of records for all Army Reserve personnel. Acquino has top secret clearance and lectures at Fort Bragg, N.C., as well as other Army bases. He reportedly is presently involved in mind control experiments at the University of Arizona. He was twice under investigation for ritualistic, sexual child abuse at the Presidio in San Francisco. No charges were ever filed against him. An adult survivor once told me the U.S. Army is Satan's army. She made this statement because of the numerous Satanists in the Army. Her father was in the Army at the time. There have been ritualistic, child sexual molestation cases at West Point, as well as the Presidio in San Francisco. [See Linda Blood's book *The New Satanists*.]

**A Boise, Idaho police officer believes 50,000 to 60,000 Americans who disappear each year are victims of human sacrifices by Satanic cults. The bodies of some victims are buried, but most are cremated so there is no body and no evidence. I know of an occult supply store in Los Angeles that sells portable crematories. Reliable sources estimate there are more than three million active Satanists in the United States.**

The FBI reports the number of automobiles stolen in the United States each year, but they do not keep a record of the number of persons who disappear. It is unbelievable that there is more concern for automobiles than for missing persons. **Some estimate the number of missing persons as high as 1.8 million per year.** Only about half are believed to be located and returned within a year. I have alerted the FBI, the U.S. Department of Justice and members of Congress to this and suggested that these matters be investigated by the federal government. My requests have been ignored.

Mr. Ken Lanning, Superior in Charge of the FBI Behavioral Science Unit, Quantico, Virginia, states that since there are no bodies, there are no human sacrifices. He claims Satanism is a religion which is protected by the *1st Amendment* of the *U.S. Constitution*. He has publicly stated there are more crimes in the name of Christianity than there are committed in the name of Satan.

Many local law enforcement agencies recognize this problem and are actively investigating. However, local law enforcement is not equipped to coordinate this at a national level. A national clearing house is needed, as well as training and seminars. The FBI already receives monthly crime statistics from every law enforcement agency in the country. It would be a simple matter for the local law enforcement agencies to add a column to their report for missing persons. [End of quoting.]

#### EVIDENCE VS. NON-EVIDENCE

Continuing with John Hunt's manuscript, [quoting:]

Over the years, there has been a lot of misinformation put out that says there is no evidence that ritual abuse or sacrifices occur and these opinions come from all corners of the world and every field of endeavor. Yet, it would seem that the examples listed below show just the opposite and still people like the FBI's Ken Lanning and *The False Memory Syndrome Foundation* say that there is no evidence and/or the memories that are surfacing are put out there by disreputable doctors, and another thought is that the people doing the killing had psychological disorders already and are just using this as an excuse.

In *Texas Monthly's* April 1994 piece, "The Innocent and the Damned", writer Gary Cartwright cites the FBI's Kenneth Lanning, now retired, as widely debunking the phenomenon of organized satanic ritual abuse. According to Lanning, Cartwright writes, "Not a single body part has been produced."

Recently, for instance, nationally syndicated columnist Molly Ivins wrote, "...social workers who deal with child abuse have nightmares about the people who come up with patently false 'recovered memories' of satanic ritual abuse."

March 13, 1981—A UPI story reports on the conviction of a Fitchburg, Massachusetts satanic cult high priest who was found guilty of the ritual killing of a woman as part of a cult ceremony.

March 5, 1986—Sean Sellers, Oklahoma. Death Row.

1989—Matamoros, Mexico—Mark Kilroy and others.

Fall, 1990—Four satanic cult member defectors in Salida, California, are brutally killed for breaking away



from the cult. After a lengthy trial in Oakland, California three satanic members responsible for the killings are now on death row. Two other cult members got life.

February 18, 1992—A *Newsday* article reports on a New York satanic cult ritual killing of a young ballerina.

July 28, 1992—CNN reported in Guaratuba, Brazil, the body of 7-year-old Yvando Caetano was found horribly mutilated. According to the CNN report, “Police say he was tortured and sacrificed in a satanic ritual.” A ritual that reportedly involved the town’s mayor, his wife, and five other satanic cult members.

May 5, 1994—Three 8 year-old boys were riding their bikes down a country road in West Memphis, Arkansas, when they were forced off the road, into some nearby woods, sexually abused, tortured, then horribly killed—apparently, again, by a satanic cult.

According to wire service reports, one of the suspects accused in the murder, Jessie Lloyd Misskelley, Jr., 17, said the murders were tied to a satanic cult, which also held regular orgies in the woods, performed animal sacrifices, and so on. According to a *USA Today* article, another suspect, Michael Echols, 18, often carried a cat skull, wrote satanic poems, and favored wearing all black.

May 5, 1994—*USA Today* reported a priestess of a drug smuggling cult and “four satanic followers” were sentenced to lengthy prison terms for the 1989 slayings (human sacrifices) of 13 people in Matamoros, Mexico. (Mark Kilroy)

Michael Newman in his extensively researched, recently released book *Raising Hell*, writes, “...cult related killers stand convicted of murder in 23 states, and at least nine foreign countries.” [End quoting.]

In an article appearing in the March 7, 1989 *Examiner*, written by Robert Boyd, [quoting portions:]

SATANIC CRIME  
IS ON THE RISE

They call her Satan’s Cop—the policewoman who is America’s foremost expert on cults and demonic rites.

Ten years ago, fellow officers laughed when she said the devil was on the rampage. Now, thousands of demon-related crimes later, they listen when she says that 1989 could be a particularly bad year for satanic crime.

And when tough, hardened Sandi Gallant says “bad”, that means trouble, because she has seen the worst that demonically crazed cults can do.

Sandi believes the police and public have only seen the tip of a black iceberg. She believes many ritual crimes go undetected because they involve children.

Says Sandi: “Too often I hear seasoned police officers say it simply cannot be true, that some kid must have made up the whole thing, that this just does not happen in a civilized world.

## DISBELIEF

“That is precisely what Satanists count on. They depend on disbelief or fear and ignorance.”

The most conservative estimates place the number of devil worshipers in America at more than four million. A report by the Adam Walsh Center, the nation’s leading investigative agency into ritual abuses, says that last year some 10,000 pre-teen American children were involved in crimes which included sacrificing animals and other demonic cult activities.

The center says last year there were 200 unsolved ritual murders in the U.S.

Says Sandi: “Just look at my case files. Wizards, witches, Satanists, sorcerers and voodooists have come out of the closet and are on the march.” [End of quoting.]

In an Associated Press article appearing in the September 29, 1986 edition of the *Daily News*, [quoting, in part:]

## POLICE NOTE RISE OF SATANIC CRIME

So many satanic messages and signs of the occult are being found at Southern California crime scenes that police officers in increasing numbers are taking courses on how to recognize them. [End quoting.]

In another article from a 1986 edition of the *San Francisco Chronicle*, written by Edward W. Lempinen, [quoting:]

## MORE CASES OF RITUAL ABUSE

Bay Area mental health workers said yesterday that they are seeing more evidence of ritual sexual abuse in children and in adults who survived intense abuse when they were young.

New cases of ritual abuse and torture have surfaced in recent months throughout the Bay Area and Northern California, said therapists and others gathered at the University of California at Berkeley.

More adult survivors are coming forward after years of silence because the public is more willing to believe them, they said. [End of quoting.]

In another article from the May 15, 1988 edition of *The Boston Herald*, written by John Impemba, [quoting:]

## POLICE MULL CHARGES AGAINST ‘CULTISTS’ DEVIL-WORSHIP ‘CHURCH’ FOUND

South Shore police are considering charges against a group of alleged devil worshippers after the discovery of their “church” inside an abandoned munitions bunker buried deep in the woods at Wompatuck State Park in Hingham.

The bizarre find was made by Cohasset and state environmental police last week when officers stumbled upon a dozen satanic worshippers dressed in black cloaks who were seen leaving the bunker.

Police confiscated numerous swords, machetes and knives, an animal skull and a silver chalice, according to John Comeau of the state Department of Natural Resources. [End quoting.]

In an article from the February 10, 1989 edition of the *Record Searchlight* from Redding, California, written by George Winship, [quoting:]

### LAWYER KIDNAP MAY HAVE SATANIC LINK

Red Bluff—A reward of \$10,000 is offered for the arrest and conviction of a man who allegedly abducted a Red Bluff attorney at gunpoint in a child custody case that may be linked to Satanism and ritualistic abuse.

“That’s the only motive we can see,” Red Bluff police Detective Ted Wiley said today of the Feb. 2 kidnapping of Cynthia Angell, 32.

Ms. Angell and her husband, Anthony Edwards, also an attorney, are offering the reward.

The man allegedly threatened Ms. Angell’s life several times if she continued to investigate links between a Tehama County child custody case and a San Francisco Bay Area children’s day school.

The man told Ms. Angell that she was investigating something that she shouldn’t and showed her a photograph of a baby whose skin had been partially removed, Wiley said.

“It looked like it could have been an autopsy photo, but the man said it was a child who had been killed during a satanic ritual,” Ms. Angell told police. [End of quoting.]

Returning to Ted Gunderson’s manuscript, quoting a section labeled simply:

Denair, September 1986—Grave robbery. Anti-religious graffiti at High School.

Los Angeles, May 1986—Richard Ramirez “Night Stalker”. 14 murders, 36 crimes. Admitted devil worship. From El Paso, Texas. Captured 8/31/85.

Los Angeles, June 1985—Animal mutilation. Animals stolen from El Camino High School.

Laguna Beach, March 1987—Laguna Beach High School arson and satanic graffiti.

Newport Beach, February 1984—5 people stole human remains from mausoleums.

**Colorado:** Trinidad, Summer 1985—Cattle mutilations. 6 cases in Northern New Mexico, 1 in Colorado. 2,000 to 10,000 over the years.

**Connecticut:** Wilton, October 1985—Satanic cult desecrated churches and threatened children.

**Delaware:** Dover, November 1986—Letters warning parents of church college students of devil worship.

**Oklahoma:** Muskogee, May 1986—Rumors of satanic cult spreading through town.

Oklahoma City, March 1986—17-year-old killed mother and stepfather. Deeply involved with cult.

**Oregon:** Albany, March 1986—Books in library on Satan and devil worship. Town upset.

**Tennessee:** Maynardville, March 1986—Murder of mother and 15-year-old daughter. Stabbed 41 times.

Greeneville, August 1986—Animal mutilations. Drinking blood. Know cult exists.

**Texas:** Granbury, January 1984—Infant’s body found in black box owned by devil-worshipping teen.

Fort Worth, December 1984—6 women disappear. May tie in with 30 other deaths.

El Paso, September 1985—Home of Richard Ramirez. Stolen jewelry, etc. found at sister’s home.

Houston, October 1980—Man caught with 8-year-old boy as satanic initiation.

**Washington:** Seattle, December 1984—Animal mutilations. Cult members spotted.

**Washington, D.C.:** February 1987—”Finders” organization. Found in Florida with kids. More of a cult-commune.

**West Virginia:** Amsted, October 1986—Rumors of satanic cult activity on Halloween. [End quoting.]

In an article appearing in the July 1982 edition of *Reader’s Digest*, condensed from *Kiwanis Magazine* by Gary Turbak, [quoting:]

MISSING: 100,000 CHILDREN  
A YEAR

About 8:30 A.M. on January 7, 1980, Katheleen Mancil drove her daughter Marian Batson to school in Inverness, Fla. “See you tonight,” Katheleen called as the petite, blue-eyed 16-year-old stepped from the car.

But she did not see Marian that night. Or the next. Or the next.

No one remembers seeing Marian after she left her mother's car. The day after her disappearance, her purse was found in a trash can about 25 miles from the school. She had joined the swelling ranks of children simply labeled "missing".

Sheila and Katherine Lyon, ages 13 and 11, journeyed to a suburban shopping center on March 25, 1975, and were never seen again. In early October 1980, two-year-old Brandy Barlow vanished from her front yard. The list goes on.

Probably the most publicized missing-child case of late has been that of six-year-old Etan Patz. On May 25, 1979, Etan walked alone for the first time to his Manhattan school-bus stop and has not been seen since. Methodical searches with bloodhounds, helicopters, psychics, and phalanxes of police have failed to turn up any clues.

These are not isolated cases. Everyone close to the missing-child problem agrees that it is a large one—and growing. Statistics, however, are tough to come by. Boundaries between runaways, parental kidnap victims and children stolen by strangers tend to blur.

The best estimates are that about a million American youngsters leave home each year, with 90 percent returning in two weeks. **Approximately 100,000 children are unaccounted for. Add another 25,000 to 100,000 stolen by divorced or separated parents, and the total becomes significant.** [*Remember, this article was written in 1982.*] "Kids who just disappear present a big problem that people had better start opening their eyes to," says Det. Sgt. Dick Ruffino of the Bergen County, New Jersey, Sheriff's Office.

Yet no single U.S. agency concerns itself exclusively with missing children on a national scale. Automobiles, handguns and silverware can be registered, traced and recovered more easily than children. "Our priorities are mixed up," says Ken Wooden, director of the National Coalition for Children's Justice. "If someone steals a car, he can be traced and caught because we have a computer system for tracing stolen cars. But children apparently aren't that important to us." [End of quoting.]

In a *Special Report* appearing in the March 19, 1984 edition of *Newsweek*, [quoting:]

### STOLEN CHILDREN

**Thousands of youngsters are abducted by strangers—  
and only a few are ever found.**

Has anyone seen Kevin Collins? Kevin is 10-years-old and 4 feet 6 inches tall, with brown hair, green eyes and a cheerful disposition. When he vanished without a trace after basketball practice in St. Agnes School in San Francisco on Feb. 10, the assumption was that he had been abducted, and the city responded with all the shocked, if usually short-lived, attentiveness such outrages provoke. While San Francisco police conducted a massive, round-the-clock search for the missing boy, volunteers distributed more than 100,000 fliers carrying his picture, the school offered \$2,000 for information leading to his return and Mayor Dianne Feinstein posted an additional reward of \$5,000.



Kevin's parents, meanwhile, offered the only thing they could, a public appeal to his abductor that seemed all the more wrenching for the self-control it must have required. "We are not interested in seeking justice or punishment," said David and Ann Collins on local TV. "We are only interested in his safe return. We love our son and we need him." A month has passed without a hint of the boy's whereabouts.

**Predatory Cruelty:** Of the approximately 1.8 million children who are reported missing each year, 90 to 95 percent are likely to be runaways or youngsters abducted by a parent involved in a custody fight. By widely varying estimates, anywhere from 6,000 to 50,000 missing children are, like Kevin Collins, presumed to be victims of "stranger abduction", a crime of predatory cruelty usually committed by pedophiles, pornographers, black-market-baby peddlers or childless psychotics bidding desperately for parenthood. Only a few cases are solved. Even fewer stranger-abducted children are recovered alive. [End quoting.]

### SOME CLOSING THOUGHTS

The above articles were written in the early 1980s. Can you imagine what the numbers are today?

When various individuals and agencies hold up the "no-evidence" theory concerning the existence of satanic activity amidst the overwhelming "body of evidence", only a portion of which you have just read, why doesn't anyone question the obvious lie and cover-up taking place?

Why will FBI representative Kenneth Lanning's opinion be held up to the world as gospel, which flies in the very face of the evidence at hand?

Why do the very agencies set up for protection of the people end up serving to suppress evidence rather than examining it?

Kenneth V. Lanning, Supervisory Special Agent, Behavioral Science Instruction and Research Unit, FBI Academy, Quantico, Virginia wrote an article which appeared in the October 1989 edition of *The Police Chief*. Lanning reaches the following conclusions in his article, titled "Satanic, Occult, Ritualistic Crime: A Law Enforcement Perspective". [Quoting, in part:]

Until hard evidence is obtained and corroborated, the American people should not be frightened into believing that babies are being bred and eaten, that 50,000 missing children are being murdered in human sacrifices, or that Satanists are taking over America's day care centers. No one can prove with absolute certainty that such activity has not occurred. However, the burden of proof, as it would be in a criminal prosecution, is on those who claim that it *has* occurred. As law enforcement agencies evaluate and decide what they can or should do about satanic and occult activity in their communities, they might also consider how to deal with the hype and hysteria of the "anti-Satanists." The overreaction to the problem can clearly be worse than the problem. An unjustified crusade against those perceived as Satanists could result in wasted resources, unwarranted damage to reputations and disruption of civil liberties. [End of quoting.]

What Mr. Lanning fails to recognize, obviously, are the rights of the children being sacrificed.

What about the rights of the parents to these children?

What about the crimes of kidnapping, torture, rape, pornography, ritual abuse, murder and cannibalism within these satanic groups? And he talks about violating civil rights? People, this is NUTS! And yet, Mr. Lanning's reports, due to the position he holds within the FBI, are held up as absolute on the subject—carved forever in stone. And so, many law enforcement personnel use his input as their directive and investigations never get to second base.

In the next part of this series, I will explore more deeply the inner workings of Satanism. Later in this series, Mr. Lanning's work will be more closely scrutinized, as well as commentary from those who take great exception with him.

When entire law enforcement agencies within our government structure turn a blind-eye to a problem of this magnitude, what does that say for our society as a whole?

At what point does the system itself become a major part of the problem, rather than being a major part of the solution?

What internal checks and balances are there to insure that the agencies themselves are held accountable in alleged service to *we-the-people*?

Alas, it's an imperfect world and one in which the New World Order is all but a finished reality. Perhaps it's better to just turn down the bed, curl up, and go back to sleep—but I don't think so. As long as freedom of speech and thought are still somewhat a reality, these questions must not only be put forth but they must be given serious consideration.

Here's an article from the June 5-11 issue of *THE WASHINGTON TIMES NATIONAL WEEKLY EDITION* about the establishment of a multi-story museum and research facility in Washington D.C. called the Victims of Communism Memorial Foundation. Now, at first glance, this may sound like a swell idea—"at last, public acknowledgment of the carnage left in the wake of Communism!" "Something to balance the Holocaust propaganda!" It's not unusual to order two meals, but it's a little different,” she said. “What was incredible was that, in between the meals, he ordered multiple bagels and muffins. When he got the bagels, he'd take out the Ziploc bags and start putting them away. He was stashing the food! He ordered at least four bagels and two or three muffins. He would say to the gal, “Can I have two bagels right now?”

“But it was most peculiar when he suddenly took one of his unopened breakfast trays and put the entire thing into a Ziploc bag, including [standard stainless] silverware! I thought, “This is really bizarre.” *[I guess! Sounds like this CFR regular is ready for a Camp David tune up! He should only have been so frugal with our tax dollars.]*

### LATEST WARNING ABOUT DRINKING WATER

Today's (6/16/95) *DAILY NEWS* contains an article by John H. Cushman Jr., [quoting:]

WASHINGTON—Reflecting widespread uneasiness over the risks of contaminated drinking water, federal health and environmental authorities suggested Thursday that people with the AIDS virus or other conditions that lower their immunity to diseases **may** want to drink only boiled, filtered or bottled water.

The cautiously worded guidance, issued by the Environmental Protection Agency and the Centers for Disease Control and Prevention, came after months of studying how to protect vulnerable groups from cryptosporidium, an infectious parasite that frequently contaminates public water supplies. *[Sounds like a watered-down suggestion! Just enough to later be able to say “We warned you”, but not emphatic enough that many will take it very seriously. Contaminated drinking water is a natural for depopulation purposes, and remember, cryptosporidium is the carrier of choice for deadly de-*

NEW WORLD ORDER KIDS:  
FLU VACCINE FOR NEWBORNS

The Haemophilus influenzae Type b (Hib) vaccine, which prevents a bacterial infection that was once a major cause of childhood illness and death, can be **safely** given to newborns, **research shows**. The American Academy of Pediatrics recommends that the vaccine be given no earlier than age 2 months, with a booster at 12 to 15 months. The Finnish researchers gave a combination Hib-tetanus vaccine to 120 healthy babies who were 2 days old, and found no adverse effects from giving the vaccination earlier. LONDON—Just a spoonful of sugar helps newborns’ pain go down, according to a **British** study. “We feel babies’ first introductions to life are painful experiences and have been looking at ways to reduce the pain. Sucrose (table sugar) has been one of the most successful,” said Dr. Malcolm Levene. The new findings further previous research by demonstrating that the more concentrated the sugar solution fed to newborns before blood tests, the less they cried, says the study, published in today’s issue of *The British Medical Journal*. VIDEO GAME VIOLENCE  
A REALITY

Concerns are raised from time to time over video game violence—a Senate subcommittee even held hearings on the subject after the release of “Mortal Kombat” in 1993. But the “games” grow ever more gruesome and deadly as technology offers increasing realism to the medium. That’s the subject of this article from a recent issue of the *LOS ANGELES TIMES*, [quoting:]

Americans are expected to spend over \$10 billion this year in interactive entertainment. [*See how we buy the rope that hangs us!!*] Once the sole province of **adolescent boys** [*See next article for follow-up*], many video games are now being bought by men in their 20s and 30s. Little research has been done to gauge the effects of the fast-evolving interactive medium. But experts say the very nature of interactivity—in which the player is invited to identify with the protagonist and often becomes physically and emotionally engaged in the game—makes it a more compelling force than other media.

“People have long been put in the position of spectator at violent events,” said Brian Stonehill, director of media studies at Pomona College in Claremont. “This takes you out of the role of spectator and into the role of murderer.”

Through the one-way glass, you can see the young Asian agent writhing in pain. Still, she refuses to talk. You are not a violent person. But you know what you have to do. You are, after all, a CIA recruit who has discovered a plot to assassinate the U.S. president. You turn up the voltage. She screams...So goes the interactive revolution. [*How can anyone think these “games” do not affect behavior? This is mind-control programming and it breaks down the taboos of civilization, making violence more acceptable—not only to perpetrate violence on another person, but more important for NWO goals, violence becomes the “norm”, we become used to it and offer no resistance.*]

## CHAPTER 7

CLOSING THE BOOK ON THE  
“VALLEY OF RADIANCE”  
AND “SATANISM IN AMERICA”

Many of you have been wondering, when will I get back to *The Valley of Radiance*? Others of you have quietly been thinking, when is he going to get off this Satanism stuff?

In *The Valley of Radiance*, I endeavored to explain, in chronological order, exactly what has taken place over the last number of years with respect to what we have been doing in this valley—with specific emphasis on the on-going legal battle over Doris and E.J. ### BUSH LAWYERS COLLECT

Here's a George Bush update from the June 10 issue of *THE ORLANDO SENTINEL*, [quoting:]

WASHINGTON—The government [*i.e., the taxpaying citizens of the U.S.*] owes former President Bush \$272,352 for legal expenses during a special prosecutor's investigation of his role in the Iran-Contra affair, a court ruled Friday. Bush had sought \$461,346, [*Classic chutzpah!*] but the panel of three appellate judges that supervises independent counsel investigations said that amount was not justified.

Before they kicked Mr. Liddy in the lip, assorted Republicans have tried to compare themselves to John Kennedy (Vice President Dan Quayle), praised Franklin Roosevelt (Speaker Newt Gingrich) and boasted of marching with Martin Luther King at Selma (Rep. Bob Dornan). Then they wonder why it is that the liberalism of Hollywood and the media is so powerful and why no one takes Republicans and conservatives seriously. It never occurs to them that by their own confirmation of the icons invented by the left, Republicans are also confirming the liberal values and policies voiced by those icons and thereby also confirming the cultural power the left has appropriated for itself.

As for the "Republican Revolution", there can be no such thing until the Republicans are willing to challenge the cultural apparatus that is the real source of liberal hegemony. They can pass all the "Contracts" they want to, but as long as the left dominates what Americans hear, see, and read, it will retain its chief power base. [End of quote.]

Public figures are constantly emerging who claim to be "conservative" and "patriotic". Where do they

REALLY stand? Mr. Francis provides an important clue in the task of reading the news with discernment, one he terms “liberal icon affiliation”. How can one take the “Republican Revolution” seriously when its leader is a big fan of FDR and the Tofflers? The official platform or position of a person, organization, or newspaper is only one item of evidence—and certainly not the most reliable one. Here are just a few clues that indicate Elite approval:

- \* Broad media exposure and acceptance, as has been lavished upon Newt.
- \* Major media-affiliated “program” or column, such as Rush, Liddy, Ollie.
- \* Pro-Israel remarks, holocaust fixation.
- \* Tendency to resort to name-calling rhetoric in place of logical analysis of a position; use of trigger words.

I am making a collection of such “indicators” and would appreciate input. It’s important to keep in mind that such indicators are pieces of evidence pointing in a direction; they are not absolutes. One could compile a long list of liberal/elite indicators on Perot, for example, but at a certain point in the ’92 election—and perhaps, still—he was the best option available for salvaging our nation.

#### GOD, A BIOGRAPHY

A recent issue of the *DALLAS MORNING NEWS* reviews *God: A Biography*, by Jack Miles, [quoting:]

It is God as the protagonist of the Hebrew *Bible*—the *Tanach*, or *Old Testament* to Christians—that concerns Miles, a **Rome-trained former Jesuit**...[*Another indicator.*] Looking strictly at what we know about God from the *Bible*, Miles presents God as creator, warrior and lawgiver. We meet a figure who destroys his creation (in the great flood) and then regrets his action. We see a God who manipulates humanity, complains to the point of whining and unleashes his wrath on his chosen people after they turn to idolatry. In short, God as a literary figure makes mistakes and, in very human terms, develops and changes.

One of Miles’ enduring themes is that God is an amalgam of personalities. There is a tension inherent in his being, so much so that God seems to be in conflict with himself. “But this makes him, in literary terms, far more dynamic and compelling, more magnetic than he would otherwise be,” Miles said. “A God who is all sweetness and light and completely unchangeable might be a consoling figure to have in the background, but it would be easy to lose interest in him.” [End of quoting.]

Why does man limit God to a ridiculous anthropomorphic caricature? Thank you for asking! It’s what we’ve learned. And look who our teachers have been: religions and religious leaders. Talk about indicators! ## CHAPTER 9

### SO YOU WANT TO PLANT A GARDEN?

#### BASIC SAFETY NET IN DIFFICULT TIMES

#### THE SOWER

*Other seed fell upon the rock, where there was not sufficient soil; and it sprang up earlier because the ground was not deep enough;*

#### CONSIDER THIS

With geophysical changes looming on the horizon, combined with awakening to the reality of nutritionless food, growing one's own food becomes an increasingly desirable idea. At some point in the not too distant future, it will become a necessity.

*"Give us the strength to encounter that which is to come that we may be brave in peril, constant in tribulation, temperate in wrath, and in all changes of fortune, and down to the gates of death, loyal and loving to one another." [Robert L. Stevenson]*

*The Golden Rule as given by the Prophet to the Shawnee:*

*“Do not kill or injure your neighbor, for it is not he that you injure; you injure yourself. Do good to him, thus adding to his days of happiness even as you then add to your own.*

*“Do not wrong or hate your neighbor; for it is not he that you wrong; you wrong yourself. Rather love him, for The Great Spirit loves him, even as He loves you.”*

Most people in cities have no idea how to begin a garden or even consider the possibility that such a thing can be done on a smaller scale using planter boxes. But for the average person in more rural areas who is unfamiliar with the often technical aspects of growing a garden, the prospect becomes too overwhelming to consider and is put off indefinitely.

*“...the Earth is utterly broken down, the Earth is utterly moved, the Earth is staggering exceedingly. The Earth shall reel to and fro like a drunkard and shall be shaken like a hut and its transgressions shall fall and not rise again.” [Isaiah 24:19-20.]*

**Well, dear readers, the time for putting off growing your garden, big or small, is past and it truly is the better part of WISDOM to take steps in this direction to insure quality nourishment in the days, months, and years ahead. I know that the time for beginning a garden may seem too late—but please remember that the garden spot you prepare will be needed and used not only this season, but for many years ahead. Therefore, even though it is late in the summer season, by all means, get busy. Also, buy a straw hat for sun protection.**

The instructions here are something that I have personally used over the last fifteen plus years. If you follow the instructions explained here, it will work and you will have food to eat. This initial financial outlay can be considerable—but in subsequent years the cost is relatively small. When you consider growing your own food rich in nutrients, the cost should be secondary. The charts within this article hold a wealth of critical information—by all means, USE THEM. Even the most sophisticated gardener can learn from the information contained within them.

*“Our old food we used to eat was good. The meat from the buffalo and game was good. It made us strong. These cows are good to eat, soft, tender, but they are not like that meat. Our people used to live a long time. Today we eat white man’s food, we cannot live so long—maybe seventy, maybe eighty years, not a hundred. Sweet Medicine told us that. He said this food would be sweet, and after we taste this food we want it, and forget our own foods. Chokecherries and plums and wild turnips and honey from the wild bees, that was our food. This other food is too sweet. We eat it and forget...It’s all coming true, what he said.” [Fred Last Bull, Keeper of the Sacred Arrows of the Cheyenne Tribe, told that to an audience in Busby, Montana, in 1967.]*

### SIZE UP YOUR PROPERTY

An obvious first step is to survey your property to see what the most reasonable location for a garden would be. Always keep in mind the availability of water. Choose a location with lots of direct sunlight. Also consider overall size—the larger the garden is the more time and water it will take to maintain. You want an area large enough to produce sufficient food for you, your family and friends, but small enough so



you are not an absolute slave to it. As a single person, starting with a garden as small as 10 feet x 10 feet is not unreasonable. I would recommend, however, that larger would be more desirable. For the purposes of this article, I use the hypothetical garden space as 20 feet x 80 feet, which is a pretty good-sized garden for a small family. When you start planting more than a quarter acre, then you've got something which will keep you tied to it with a ball and chain.

If you only have an area where there is a lawn, consider pulling it up and planting a garden instead. In difficult times you won't want to eat the lawn—or perhaps I should say: you may want to eat the lawn but a garden will look a lot better.

In times of drought, a small, intensively grown garden is highly desirable as the yield is very high and it requires less water than traditional farming methods.

*“No one should control more arable land than he can maintain in a high state of productivity, the four great factors of which are good seed, suitable moisture, abundant available plant food and rational tillage. In a large majority of cases where failure, or partial failure of an abundant crop is observed the meagre results are due to a partial lack of one of these four fundamentals.”* [Isaac Phillips Roberts from *Ten Acres Enough*.]

## SEED

Once you've decided to put in a garden, then you need to choose what you'd like to grow—always keeping in mind the specifics about your particular geographical region and the time of year. **GET YOUR SEED ORDERED ONCE YOU'VE GIVEN SOME CAREFUL CONSIDERATION TO IT, AND THAT WAY THE SEEDS CAN BE ON THEIR WAY TO YOU WHILE YOU COMPLETE OTHER ASPECTS OF THE GARDEN PREPARATION. ORDER SEED FIRST, THEN PREPARE THE SOIL. ALSO, ORDER NON-HYBRID OR SO-CALLED “HEIRLOOM” OPEN-POLLINATED SEED.** With this type of seed, which is rare in this country, you may replant year after year after year using seed from your own crops. Most seed at grocery stores, hardware stores, and most seed companies are hybrid—which means that you can only use the seed for one growing season—and then you need to repurchase seed for the next year. **THIS IS SOMETHING YOU WANT TO AVOID IF AT ALL POSSIBLE. PLAN ACCORDINGLY AND ORDER NON-HYBRID SEED—IN THE YEARS AHEAD YOU AND YOUR FAMILY'S LIFE COULD DEPEND ON IT!** Here are some non-hybrid seed companies that I strongly recommend you communicate with and get their catalog: [Please tell them *CONTACT* sent you.]

#### HIGH-YIELD GARDENING—RAISED BEDS

*“...ere long the most valuable of all arts will be the art of deriving a comfortable subsistence from the smallest area of soil. No community whose every member possesses this art can ever be the victim of oppression in any of its forms.”*

[Abraham Lincoln, 1859.]

Once you’ve identified the location for your garden, then the work really begins. This article will concentrate primarily on raised-bed gardening, which is referred to by various names. The beds generally are rectangular in overall shape, varying in width from 3-5 feet across and whatever length you determine but if the shape of your particular piece of land is such, the beds can take on curves or even become circular. The finished beds are elevated above the ground, anywhere from six inches to a foot high. But let’s begin with soil preparation, because without that there won’t be any food for the table.

Why raised beds? Well, for one thing, raised beds can solve a wide range of gardening problems. Here are just a few:

Spectacular yields depend first on soil conditioning that can readily meet the heavy demands of close planting, carefully timed successions, and a growing season stretched to its absolute limit.

*“Teach us to know and to see all the powers of the Universe, and give to us the knowledge to understand that they are all really one Power.”* [Black Elk.]

I will assume that most of you putting in your first garden will not go to the trouble of having your soil actually “tested”. But if you do, keep in mind that most plants thrive on a pH range anywhere between 6.0 and 7.5. A good rule of thumb would be: Assume your soil is very poor and needs amending with nutrients and organic matter. It is essential to have organic material in the soil, such as manure, compost, minerals, or combination amendments which loosen the soil to allow for retention of moisture and healthy root growth. If you are purchasing manure, be sure it is “aged” 6 months to a year—otherwise you’ll end up with a lot of weeds and grass seed in the garden. Most bagged manure at nurseries is sterilized and aged. In many rural areas manure is readily available from local ranchers and is generally advertised in the want-ads, and often will be delivered for a fee. Larger gardens can require quite a few cubic yards of manure and it is considerably less expensive in bulk—however the danger comes in not knowing if it is “aged”, and that can really make the difference if you end up with a huge pile of grass or weeds in your garden.

Go out to the area you’ve chosen as a garden spot and carefully examine and feel the soil. Here is one guide which may be useful to you.

*“Creation does not take place where there is a scattering and dissipation of energies. ### PREPARING THE SOIL

The next intermediate step will be to till the soil. Many gardening purists insist on digging by hand—but I have found over the years that a rototiller can be a good friend indeed.

There are a variety of excellent books available on the subject of raised-bed gardening, and most go into great detail about double-digging the beds by hand while adding various soil amendments. The instructions I am providing here are geared for those of you readers who have never planted a garden, aren't particularly interested in digging a quarter-acre plot by hand but would still like to prepare some soil in which to grow food without killing yourself in the process.

Tilling is best when the soil is somewhat moist but not soaking wet. Many types of tillers are good; I prefer Troy-Bilt. Very dry soil is difficult to break-up and the tiller will tend to "buck". If you are starting your soil preparation during the summer months, you may have to heavily water the garden area over a period of several days and then wait for it to partially dry out. Somewhat moist is best—soggy wet is not.

Once you've tilled the soil so that the top foot or more is loose, then you are ready to begin adding the necessary soil amendments to properly build up the soil. Here are some guides for your assistance. Depending on where you live, your local nursery can provide you with a wealth of information. Different nurseries have different soil amendments. There are many excellent "soil building" products on the market—some organic, some not. Don't get too "hung-up" on a strictly organic approach, but you certainly do want some organic matter mixed into the soil for healthy root production for your crops. What you elect to use may very well be determined by what is available in your area. I have often been frustrated by this one point. Try not to be—use what is available to you.

Once you've purchased and spread your soil amendments (which can include manure, organic compost, and other material) across the entire surface area of your garden spot, once again, till the soil with the rototiller—or dig by hand if you are so inclined.

Fertilizer, whether organic or commercial, should be spread across the top of the completed beds and then lightly worked into the top several inches of the soil. Therefore, when spreading amendments for tilling into the soil, hold the actual fertilizer aside for the final step after the beds have been constructed.

## BED CONSTRUCTION

Once you've spread the soil amendments over your garden area and have rototilled it thoroughly, next comes the hard part (physically). For the sake of discussion, let's say your garden area (plot) is 20 x 80.

At this point you'll be needing a flat, square-end shovel with a short handle. Beginning at one end, shovel an outer pathway along the 80 foot side. The pathway will be approximately 18 inches wide. As you shovel (deeply) the soft, tilled soil, throw each shovelful right next to you as you go—on what will be your first bed. The beds will be, on the average, about 4 feet across. You could, theoretically, have a bed which would, in this case, measure 4 feet by 80 feet. (It is nice to break up these long beds with cross pathways for ease of moving around in the garden.)

When you have finished shoveling your first outer pathway by placing the excess dirt onto your first bed—then measure 4 feet across and mark it with occasional stakes or with stakes and a long string. Then, beginning at one end along the 20-foot side, 4 feet in from the 80-foot outer edge, begin shoveling an inner pathway. The pathway should be whatever width you are comfortable with—don't crowd yourself—18 inches is a good standard (less if space is limited). With the first shovel of dirt, throw it immediately to your left. With the next shovel, to your right—left then right, left then right until you are all the way across the 80-foot length of land. You now have an outer path, one 4-foot very rough looking bed, another path, and then the rest of the plot. Repeat the process. In the end you will have 4 raised beds, approximately 4 feet across and 80 feet long.

### SHAPING THE BEDS

Now, using a long-handled (preferably wide) rake you will begin to shape and even out the beds. The beds should be, for all intents and purposes, flat on top.

When there is a lot of organic matter in the soil, the beds can be shaped as rounded mounds, but for purposes here I'll generically describe them as "flat-surfaced". You'll be able to tell by the texture of your specific soil what is the most appropriate shape for your unique garden. A flat surface tends to be the easiest to work with.

With the flat-surfaced bed, sides should be at a 45-degree angle to the horizontal—in other words, a moderate slope upward. As you work with the dirt you will develop a "feel" for it.

Once you've completed the general shaping of each of the beds, you should be pretty tired, so, take a break and have some lemonade.

Now, sprinkle the chemical or organic fertilizer evenly across the top of each bed. Then, gently work the fertilizer into the top several inches of the beds with a rake. When complete, smooth the entire top of each bed to a flat surface. Then, take a piece of plywood, say 2.5' x 4' and place it across the far end of the first bed. Stand on top of the board and gently jump up and down—you will flatten the surface of the beds to the extent that they will keep their shape in all weather conditions. Step off the board, move it slightly and repeat the process until the entire surface is gently flattened. Do this to all of the beds.

I would also recommend, with the beds now complete, that you drive wooden stakes into the ground at various spots around the edge of each bed—say, the four corners and then every six to ten feet—right up to the outer edge of the bed. These stakes, say four inches wide, 1 inch thick, by 1 foot long—will serve as "hose guides". As you drag hoses around your garden, this will prevent the hose from running up the sides of your beds and destroying your plants (which can often happen in a mere moment).

## FENCING

Prior to planting and depending upon where you live, you may want to consider putting up a wire fence to keep out dogs and cats and animals like rabbits who may view your garden as theirs. Just one animal can do a great deal of damage to the completed beds. Cats will often use the soft dirt in a freshly prepared garden bed as a “litter box”.

Generally speaking, fencing your garden is a good idea.

## PLANTING

Using the raised-bed method of gardening, due to the loose soil structure, you are able to plant the rows closer together because the roots themselves grow straight down rather than flattening out with harder soil. You are also able to plant closer together within rows. Therefore, the overall yield is higher in a smaller space. Due to the high percentage of organic material in the soil, by using the raised-bed method the plant’s root structure develops more fully and is, overall, healthier. A healthy root structure equates to greater yield of food production. The old saying, “Everything is connected to everything” really applies to gardening.

A good recommendation, even though slightly more costly, is to “sow heavy”—that means, use quite a bit of seed within the rows while you are planting and then “thin out” the plants later. This will prevent bald spots or open spots within the rows. Also, a common mistake for new gardeners is to plant the seed too deep—don’t do it.

You want to plant (and later thin) in such a way as to have the mature leaves of the plants touching one another row-to-row. This creates a “mini-green-house effect” or a “living mulch” effect which softens the negative effects of hot mid-day sun. After all, sun-scorched plants must first repair damage before devoting energy to further growth development. Planting in this manner also shades the topsoil, thus preventing excessive water loss due to evaporation and it also discourages weed growth. The raised-bed method of gardening is really the very best of many approaches. And, by the way, with raised beds you don’t have to lean over as far to harvest or pull weeds throughout the season. I believe this is why the Irish refer to raised beds as *lazy beds*.

You will probably want to plant some flowers throughout your garden. They add color and some, such as sun-thriving marigolds, deter insects. Plant flowers that you’d like to see and use for dinner-time table decorations. Mix it up a bit.

Also, when planting, don’t plant all of any given crop at the same time—particularly with something like lettuce. Plant a few rows, then leave some open space for a second, or rotation planting. That way you always have fresh lettuce when the old lettuce has *bolted*, or gone to seed (which tends to happen in very hot weather). Here is a chart to assist in your planting.

### WATERING YOUR GARDEN

Once again, don't be a slave to the garden unless you want to be. We live in a modern age and one in which, thank God, there are digital, battery-operated automatic timers which you can attach directly to your faucet and garden hose system. It is possible to program up to 4 waterings per day with a quality timer, which is well worth the expense in the time it saves you. Keep in mind, while the timer waters the garden, you can go somewhere else.

Just a few tips—while it is true that overwatering is a common problem, underwatering is a real mistake—particularly in the very beginning of germination. **DO NOT LET THAT NEWLY PLANTED SEED DRY OUT—EVER.** If you are watering several times per day by hand, you will literally be able to tell when enough is enough. If you are using a timer, which I DO recommend, you'll just have to play with it a bit to get it “just right”. But under no circumstances let the seed dry out. I cannot emphasize this enough: It is better to overwater, if you must, than to underwater in the beginning. Besides, the raised-bed method of gardening will be more forgiving of a bit of overwatering than will a regular, hardpack farming method.

But what kind of sprinkler should I use, you may ask? **AN OSCILLATING SPRINKLER IS, IN MY OPINION, THE MOST PRACTICAL.** Also, they do have plastic Y adaptors to allow for two hoses, and thus, two sprinklers off the same water line. Keep in mind, I'm giving instructions here for a low-maintenance garden that will grow quality food. If you want to live in the garden day and night, that is your choice and you certainly are free to do so. My only point here is that over-work isn't necessary to get results that you'll be delighted with.

### WHAT NOW?

If you have followed the instructions to this point, you're there! As the vegetables begin to grow, thin them carefully. I always recommend using a sharp knife when harvesting. For example, when harvesting lettuce I like to cut away the outer leaves while letting the plant continue its growth. Experiment.

I believe you will find that growing a garden is an extremely rewarding experience—not to mention the quality of food you'll soon be eating! If it is done right, it can even be FUN. Learning about gardening is a lot like life—it takes time and just goes on and on and on. The secret lies in beginning.



If you've completed the garden, you've accomplished a great deal. A garden at home is worth ten insurance policies, because when all is said and done you can now go out into your own back yard and pick your next healthy meal. Well done!

COMMUNIST MANIFESTO 1/30/91 #1 HATONN

[QUOTING:]

Americans, who have been watching the degeneration of our society, the increase in violence, drugs, pornography, and the national debt, often write us for advice about what to do “once the nation falls” into Socialism, insolvency and surrender. Some use the forbidden “C” word, by asking what they should do “when the Communists take over.” My friends, when the Thought-theology (psychopolitics) of what we understand is Communism finally takes over in America, ***it will NOT be called by that name. The Hammer and Sickle will probably never adorn any flag. (Communism will be called “democracy” and accepted by most Americans with dancing in the streets!)***

Does this sound preposterous? Think about it. How would you know “when Communism, sold as democracy,” is the ultimate law of the land? If those who are now employing “more powerful levers and more subtle webs” succeed in their plans, most of those living in this country may not notice much of a difference from what they think of as the American Way these days!

Karl Marx, the Jewish hippy who invented what is known today as “Scientific Socialism”, was not himself a Communist and never claimed to be one. Mr. Marx, it is now known, collaborated with some wealthy totalitarian Socialists, and they let him put his name on their joint effort, and it was titled, the *COMMUNIST MANIFESTO*. It was a scheme of powerful levers and subtle webs. There is so little difference between Socialism and Communism that 70 years after the *COMMUNIST MANIFESTO* was published, Lenin, the Socialist founder of modern Communism, called himself a Communist but named Russia and other conquered territories the Union of ***Socialist*** Republics. Regardless of what Communism is called, it would be identified by at least ten basic planks as set forth in the *MANIFESTO*. These political planks need to be listed here, not only as a review but as a template by which to gauge the American government and policies today. **[H: I have given you all of these but perhaps you will see and hear more clearly if they are again laid forth from Earth-man.]**

1) ABOLITION OF PROPERTY IN LAND AND  
APPLICATION OF ALL RENTS TO PUBLIC USE.

Did you know that the Federal Government of Washington, D.C. now owns over 40% of the land mass of the United States? That is more land than the entire country east of the Mississippi River. It does so in direct violation of the *United States Constitution*. The Federal Government now owns more than 10% of all industrial properties, and owns railroads, barge lines, etc. As the government buys more and more land, this property is taken off the tax rolls, and this increases the taxes all of us must pay on the land we suppose that we own. Most Americans think that they own their land. They think that a certain parcel upon which they live actually belongs to them. Have your lawyer explain to you why your deeds have been drawn as they have or why you and your wife are called “tenants in common” and other strange language and phrases. Here is the rule of law: If you must pay the state or county a “property tax”, and the state or county can sell your property to someone else if you fail to pay the tax, you are not the actual and lawful owner of that land or property! Marx called the use tax on land, rent. Today it is called “property tax” and while universally accepted by most Americans, the property tax is 100% Marxist (Communist) in nature. How then will you know when “Communism takes over?”

The land that is still informally held in private hands, is now subject to state and municipal controls called

“land use” and you can only do certain things on land that you suppose you own. If you actually owned it, instead of being merely a “tenant with a vested interest in it”, no city, state or federal controls could be imposed upon it. Yet, you accept zoning restrictions as normal and allow the city to impose “rent controls”. You sit tight when the Federal Government tells you, via an unconstitutional statute, that you must rent “your property” to anyone who comes to your door, regardless of race, color, national origin and sexual preference. From where did they get the lawful jurisdiction to tell you what you can do on “your property”? If indeed it is your property, there is no such authority except that which you voluntarily submit to. However, since you are merely a tenant paying property use tax rent on the land, they have every right to tell you how you will use that property and how far from the property line you must build any house, etc. Can you imagine Patrick Henry putting up with such nonsense? Of course not! But then, Patrick Henry was a Freeman, not a Communist. He did not hold Communist ideas about the use of land, as most Americans today do. How about you? Are you a Communist when it comes to land use? As to the use of land, every Senator and every Congressman is a Communist today. Nothing much will change “when Communism takes over”, except that you will know that you are a mere tenant and not a land owner as you had supposed for years. Some of you tenants will be pushed off the state’s land so that another tenant can use your nice home and farm and if you illegally resist, you may be legally shot.

When the Communist agent, Woodie Guthrie, wrote the now famous song, *This Land Is My Land; This Land Is Your Land...* he was writing with the Communist understanding about land and land ownership. Yet patriotic groups, ignorant of Communist objectives, often sing that song with the same attitude and reverence as they do with *America, The Beautiful*. Good grief!

## 2) A HEAVY PROGRESSIVE OR GRADUATED INCOME TAX.

This is probably the best known of the Marxist-Communist political concepts in use today in America. If there is any Communist statute or regulation that has been imposed unlawfully on most Americans, and one which affects their very lives and fortunes the most, the Communist Income Tax has to be it. If there was any statute that employed more “powerful levers” or “subtle webs”, you would be hard pressed to find it. As with the progressive tax on property, it is a Communist idea of “from each according to his ability and to each according to his need” that finds exact expression in the federal and state graduated Income Tax laws. Yet 90% of all Americans accept that system of federal revenue taxation as if it were both Scriptural and American. It is neither. It comes from the *Babylonian Talmud*, and is the main cornerstone of Communist Thought-theology; Marxism-Leninism is not only a political thought, but is also the religion of the Communist-Socialist. I was sitting at a restaurant meal with two Baptist ministers and their wives recently. These men had come to see me regarding several theological opinions that I hold and set forth in *STAR WARS 4*. During the discussion, the subject of the Marxist Federal Income Tax came up, and I stated that I had not filed a return in over 20 years. One of the minister’s wives blurted right out, “I think I should turn you in!” Here was a woman claiming to be a Christian who was perfectly at ease turning in another Christian to the federal authorities over the matter of a Communist taxing system! What did the two ministers say concerning the outburst from this wife? Nothing. Now, how could they understand the deeper meanings of *STAR WARS 4* when they were functional Communists in Thought-theology (Psychopolitics)? Here is a plank of the *COMMUNIST MANIFESTO* so ingrained in their sub-conscious minds that they were silent when this woman suggested that I be turned over to the authorities! It is a well-known hallmark of Communism when you see people turning in their neighbors to the authorities. It is now

beginning on a large scale in America with such carefully prepared TV shows as *UNSOLVED MYSTERIES*, where the TV uses brutal murders, drug and child abuse crimes to get the public accustomed to thinking about turning people in so as to solve these crimes. You will become a “state hero” and even be paid \$1,000 for your help. Next, you will be paid for turning in people who own firearms or teach the citizenry about unlawful government activities. Will you really *recognize the point “when Communism takes over?”*

### 3) ABOLITION OF ALL RIGHT TO INHERITANCE.

In spite of the federal Estate Tax of 1916, your Marxist government has yet to accomplish this objective. They have imposed a heavy inheritance tax, illegally confiscating a large part of that property a man leaves to his children. After a couple of generations, the property is gone. How many people do you know who still live on their grandfather’s farm or ranch? Naturally, the lower classes, who have chosen not to save enough to purchase property, have no inheritances to leave. The super-rich have been provided the use of tax-exempt foundations so that their wealth is passed on to their posterity. It is the great middle-class that the Marxist objectives are directed toward, and which succeed very well in America. Where does the Federal Government get the authority and jurisdiction to tax the property of the deceased?

### 4) CONFISCATION OF THE PROPERTY OF EMIGRANTS AND REBELS.

Emigrants are people who *leave* a country, and that does not apply to Americans. However, look at what is done to Americans your government calls “rebels.” All your government needs to do is allege that a person is a “tax resister” or a drug pusher and his property and real estate can be confiscated without due process. Some of you saw the story on *INSIDE EDITION* where a citizen’s property was taken by the Federal authorities without due process merely because she had rented the house to people later determined to have been using the house for drug traffic. All your government needs to do is allege that property, real estate, cars, boats, etc., are owned by those involved in drugs, and this property can be taken and sold under Public Law 99-570 set in place in 1986. You have read the horror stories. Some minimum wage seaman can sneak drugs aboard a million dollar ship, *unknown to the owners or the captain*, and the ship is confiscated by the government without due process of law! *HOW WILL YOU KNOW WHEN COMMUNISM TAKES OVER?*

### 5) CENTRALIZATION OF CREDIT IN THE HANDS OF THE STATE, BY MEANS OF A NATIONAL BANK WITH STATE CAPITAL AND AN EXCLUSIVE MONOPOLY.

It was through the Federal Reserve Act of 1913 that the private banking cartel known as the FEDERAL RESERVE BANK came into being. It is through this scheme, with the government controlling the banks and credit for the benefit of the secret shareholders, that the effect of this objective of the Communists came into being in the United States. The super rich bankers, while they liked the controls envisioned by Karl Marx, decided that all the usury and profits should go into *THEIR* pockets instead of the federal coffers. It is this small bank of International Bankers who decide how much interest you are going to pay



on your home mortgage and they have the monopoly power to force other banks to charge the same rates. Individual credit can be given or withheld at the whim of these bankers. The private FEDERAL RESERVE BANKING SYSTEM is neither “federal” nor does it have any “reserves” as commonly thought. The local Federal Reserve Bank is not listed under agencies of the Federal Government in your phone book, but listed in the white pages as any other private business.

The FEDERAL RESERVE NOTES, which you carry in your pocket, though printed by the Federal Government for those private banker’s use, and identified as “legal tender”, are in fact privately circulated bank notes. As “notes” they do not certify that the U.S. Treasury has gold or silver to “back them” but state on their face that the U.S. Government is in debt to that amount. You are not paying your bills with certificates of wealth, but with evidences of federal debt. You are passing the U.S. debt to the bankers around among yourselves as if it was lawful money. The *private* Federal Reserve makes huge profits for its member banks, **and yet it pays no federal or state Income Taxes**, and they have never been audited by any government agency. A couple of years ago, Senator Metcalf of Washington State launched a campaign against the FEDERAL RESERVE and had it put on the ballot to restore the right to create money to the Congress as specified in the *Constitution*. The people in Washington State were so ignorant or Communist-minded that they actually voted it down! **HOW WILL YOU KNOW...?**

In 1933, when so many banks lost their shirts and had to repay their depositors or close their doors, the FEDERAL RESERVE ACT was changed to incorporate the Federal Deposit Insurance Corporation (FDIC) [H: Note “**Corporation**” which designates private.] Here is how that works, and we can see it with the current Savings and Loan scandals. In good times, the bankers make huge profits. However, in bad times, the American taxpayers are called upon to bail out the bankers, letting them retain their personal assets. How will you know when “Communism takes over”? Most people are so accustomed to the yoke of Communism, thrust upon them in the name of “democracy” and “Social Security”, that they believe that these things must be the form of government our Forefathers gave us. They think it is normal to have total taxes in amounts to 50% of income. Where is their Great Republic based upon the Common Law and the *Constitution*? For all practical purposes, it no longer exists.

#### 6) CENTRALIZATION OF THE MEANS OF COMMUNICATION AND TRANSPORTATION IN THE HANDS OF THE STATE.

All radio and television networks are licensed and permitted to operate only at the good pleasure of the Federal Government through the Federal Communications Commission. Because their programming is under strict federal guidelines, anti-Communist programs are rarely aired. How many of you can recall one TV program, in the past 30 years, which set forth the Communist objectives for the conquest of America and the world? Instead, all programming is designed to promote Socialist thinking, and our country is never referred to as a republic but **ALWAYS AS A DEMOCRACY**. All news is designed to promote the Communists and their leading individuals as reasonable people, and anti-Communist nations, such as South Africa, are always cast in an unfavorable light. Communist objectives for America, such as degeneration of moral values, interracial marriage, promiscuous sex, and homosexual life styles, are treated in both the news and the “situation comedies” as totally normal and health behavior, and are given to us and our children on a daily basis. All transportation by air is under either the Federal Aviation Agency or the Civil Aeronautics Administration, and the government controls how these private businesses operate and



the fares and rates that they can charge. The Federal Government controls every form of interstate commerce, and sets the rates that these private businesses can charge and even how long a truck driver can drive his own truck in a given day.

7) EXTENSION OF FACTORIES AND  
INSTRUMENTS OF PRODUCTION OWNED BY  
THE STATE; THE BRINGING INTO CULTIVATION  
OF WASTE LANDS, THE IMPROVEMENT OF  
THE SOIL ACCORDING TO A COMMON PLAN.

The Federal Government now owns and operates more than 25,000 corporate units in direct competition with private enterprise. Most of these corporations are operated at staggering losses, even though they pay no property taxes and no interest on invested capital. All of these, along with their losses, are being operated without the slightest shred of Constitutional authority. Furthermore, according to figures taken from the Federal Budget, the aggregate losses of these federally owned businesses and property, including the lost state and local taxes thereon, exceed the total amount collected each year on the personal Income Taxes! According to the LIBERTY AMENDMENT COMMITTEE, from whom these statistics were taken, the sale of these unlawfully owned businesses would retire about one third of the national debt, and make the personal individual Income Taxes a thing of the past. This author is 100% in favor of bringing wastelands into cultivation and improving the soil. However, this must be done on a private enterprise basis, and not as the result of federal bureaucratic intervention. However, in accordance to the Marxist orientation of our government, swarms of New Officers (to use the language of the *Declaration of Independence*) have been descending upon our farmers. There is the Bureau of Land Management, Bureau of Reclamation, Bureau of Mines, Environmental Protection Agency, and many others. I do not need to comment on the crisis now being faced by America's independent farmers. It is not the result of incompetent farmers but because of federal meddling in both their agricultural and financial affairs.

8) EQUAL LIABILITY OF ALL TO  
LABOR, ESTABLISHMENT OF INDUSTRIAL  
ARMIES, ESPECIALLY IN AGRICULTURE.

In the first sentence, the emphasis should be on the word, *liability*. This is to be a "worker's paradise" and therefore all have an equality liability, a pecuniary obligation, to labor. Every citizen, according to Marx, is required to labor, and every person is to be assigned a job. There is to be no non-laboring middle class working as salesmen and shopkeepers. In spite of massive government boondoggles in agriculture, the American farmer has found a way to produce food that feeds not only our country, but those countries as the USSR and China which still suppose that the Marxist way for agriculture may someday work. Once the farmers finally fail in large numbers, not because of agricultural flaws so much as corporate debt, the Marxist agriculture armies, gathered from those "huddled masses yearning to be free", that now clog up the welfare rolls, will be sent forth to plant, till and harvest in the vain hope that they can feed the people.

9) COMBINATION OF AGRICULTURE WITH

MANUFACTURING; GRADUAL ABOLITION  
OF THE DISTINCTION BETWEEN TOWN  
AND COUNTRY BY A MORE EQUITABLE  
DISTRIBUTION OF THE POPULATION  
OVER THE COUNTRY.

The destruction of the cities has been going on since the Roosevelt Depression. Socialist confiscatory property and business taxes on producers, and welfare handouts to non-producers, have driven commerce and industry out of the cities and provides the excuse for federal control of land use, environmental impact studies, and regional planning. Federal regional planning done between states and over state lines, is the way this Marxist plank is being carried out today.

10) FREE EDUCATION OF ALL CHILDREN  
IN PUBLIC SCHOOLS, ABOLITION OF CHILDREN'S  
FACTORY LABOR IN ITS PRESENT FORM.  
COMBINATION OF EDUCATION WITH  
INDUSTRIAL PRODUCTION.

When Karl Marx wrote “free” he meant *compulsory* education of the children under the control of the State. Because of the contract with the State known as the “Marriage License”, your children are legally Wards of the State. They must have “shots” and a Social Security number “required to protect the State’s wards”. State-run and tax-financed government schools began soon after the publishing of the *COMMUNIST MANIFESTO*, with the key leader at that time being Horace Mann. Next came socialized or often called “progressive” education under the guidance of John Dewey. How many of you remember having to read about the wonders of Socialism in books by Lincoln Stephens in high school? The most Socialist class in any high school is not history or social science but English, where the teacher can direct the children to read certain books and make reports on them. English is the only required class for all students, and it is there that the Communists have directed their most attention. Under Biblical law, early American instruction, where students were studying Greek and Latin by 9 years of age, has always been the responsibility of the parents and their church assembly. Children were taught the moral values of the parents and of their church. Today, it is the State that determines what the standards will be for the children’s education. Federal Aid to Education determines how the States will set up the basic teachings and philosophy and this is exactly what Marx had in mind. This form of education teaches the child to look to the State for help, and the State becomes the child’s “god”. Christian instruction, in contrast, teaches the child to look to God, and that if he needs a hand he finds one at the end of his arm. As you look at our youth educated in government schools, observe their appearance and their attitudes, and remember that crime and drug use is increasing seven times as fast as the population, you will see the evil genius of Karl Marx in full bloom. As you re-read this section, notice that I have drawn a clear distinction between “instruction” and “education”. It is Humanistic, New Age, and Eastern philosophy that man is intrinsically good. Hence the use of the word “education” by the modern Socialist, which means from the Latin, “draw the good out”. In contrast, the *Bible* teaches that all men are sinners, and that they are basically of a sinful, wicked nature. Thus, there is no way to “draw good out” of them. Christian philosophy, based upon the truth of the *Bible*, teaches that children are to be *instructed*, that is to have the good of God’s Laws put into them so that they can be pleasing in God’s sight. Today, those church groups that teach that God’s Laws are still in full force and effect, always refer to their schools as Christian Instruction. Those churches who have gone the

way of Humanism, teaching that God's Laws, Statutes and Judgments were abandoned at The Cross, rightly call their schools "Christian Education". The term "Christian Education" is an oxymoron, an absurd contradiction in meaning to those of us with even a smattering of classical study.

As to the second part of Marx's 10th Plank, children under 16 are not permitted to work for wages. All private apprenticeships have been abolished for children seeking to learn a trade before the age of 16. Roosevelt's Socialist friends had the Fair Labor Standards Act passed in 1937 where apprenticeships are now under control of the State.

I have taken six pages to teach you what Communism really is from the works of their founders, Karl Marx. Now, fellow American, **how many of the Marxist Ten Planks have you accepted as normal, necessary, and indeed the American Way?**

**[H: Please pay close attention to that which I will now quote from the same document but bearing more attention. After that I shall again ask Dharma to outline the *Executive Orders* which are now signed and in place in your government.]**

J. Edgar Hoover, in his classic book on the Communist threat to America, *Masters Of Deceit*, wrote that his greatest fear was that Americans would become "state-of-mind Communists" while adamantly denying any interest or adherence to Communism. My friends, that is exactly what has happened. Most Americans go along with every single plank of the *Communist Manifesto* and even suppose that it is the American Way!

**Now, my friends, the more powerful levers and more subtle webs have been set in place.**

Several months ago I wrote about the Marxist Income Tax and the reasons why I was opposed to it. I further stated in public print that I had not filed any returns for 20 years nor paid any tax in all that time. These ON TARGET *Northpoint Team Reports* are widely photocopied and circulated with my permission and encouragement. However, they go from friend to friend and then to the Christian ignorant among the silent majority, and ultimately to the Socialist enemy. You cannot believe the letters we get from professing Christians! I have read their letter admonishing me to read *Romans 13*, supposing that I had not managed to read that far into the *New Testament*. They call my attention to Christ's words to "render unto Caesar..." and think that whatever is demanded by government under a pretext of law must be dutifully turned over to Socialist schemes, heathen peoples around the world and social dropouts around the country as part of our Christian witness, testimony, and responsibility.

According to these Christians, educated into the Communist Thought-theology psychopolitics of the government schools, apparently the American Colonists should have paid the tax on tea demanded of King George instead of "damaging their Christian testimony in an act of violence" by dumping it all into Boston harbor. The tax was, after all, "the Law" and imposed lawfully by those in authority. Worse than that, when the King wanted to confiscate "assault rifles" being stored in Concord, "Christian patriots should have turned them over to the Red Coats instead of killing people at Concord Bridge".

Those early Americans are identified as Patriots, but those of us who object to the very same things today are thought of as unAmerican at best and unChristian at worst. Do you see the problem we have today? Christians are now "state-of-mind Communists" as feared and predicted years and years ago. How do I

reason with a “state-of-mind” Communist, who supposes that his political, moral and economic understanding comes right out of the *Bible*?

The Federal Income Tax Statutes, and the Supreme Court decisions supporting them, clearly state that wages and salaries are not “income”. Yet Christian Communists in America, in what profess to be patriotic assemblies, have been conned into waiving that statutory provision and to “voluntarily” agreeing to pay the first part of their increase not to God’s Law but to Caesar, in direct violation of God’s Law set forth in Scripture. And they wonder why God stopped blessing America right after the Marxist Income Tax Statutes went into effect! Looking deeper still, we find that even the Marxist Income Tax Statutes made Constitutional by the *16th Amendment*, applies only to those non-white citizens **by privilege of the 14th Amendment**. It also includes corporate officers, folks who live in Washington, D.C. and other Federal enclaves, military people and those who work in government jobs. But, people who exchange their time for wages, salaries, commissions, etc., are not required to file returns or pay federal taxes. Oh, your minister never told you these things? And your dad never knew them? Why are you giving the first portion of the wonderful blessings God gives you through increase of your land and labor of your hands and mind, to promote Communism, totalitarian Socialism and other wicked things at home and abroad? Shame on you! Repent of your ways.

I will tell you why you pay without a whimper! It is because you are scared to death of the wicked agents of the Internal Revenue and their well-publicized cruel activities and brutal enforcement procedures. Most of you lack the guts for such basic Christian service to your country, if the truth was really known. Some of my best friends and most generous supporters have confessed this fear to me privately and I have wept for their souls. You must understand, Scripture teaches that the fearful, right along with the unbelievers, murderers, whoremongers, sorcerers, idolaters and liars shall have their part in the lake which burns with fire and brimstone. Read *Revelation 21:8* about those listed among the non-overcomers! Those who are afraid, are just as wicked in God’s Eyes, as some of the most terrible of anti-Christ people! Take your *STRONG’S CONCORDANCE* and do a word study on all the variations of the word fear and it will open your eyes of understanding. Oh, how I pray that some of my wonderful Team Members and other financial supporters will turn from their fearful ways and not be included among that wretched lot at the end of time.

Did you know that if you file Income Tax returns, you place your legal status under Admiralty Law, and waive your Common Law rights under the first Ten Amendments to the *Constitution*? The fearful, under an ironic twist to God’s Law, find themselves unprotected by the *1st Amendment* and cannot lawfully claim the right to religious freedom or the right of free speech, etc. They cannot claim the right to keep and bear arms as set forth in the *2nd Amendment*. Since so few Americans remain who have these rights, the laws on the gradual confiscation of any “semi-automatic weapon” are now being enacted, beginning with the so-called assault rifles, and hand guns that have an ammunition magazine or “clip”. Are you surprised? These laws have been on the books for 20 years awaiting this day and hour! I know that some do not believe me on this, but see for yourself. Go to your local library and ask the librarian to show you where the *UNITED STATES CODE* books are shelved. There are 25 of these in the set, reddish-brown in color. They are printed by the United States Government. Select Volume 9 and turn to page 554. Read public law 87-297 signed into law by John F. Kennedy in 1961. Every President since then has worked to gradually enact its provisions, knowing that most Americans would not approve. Read along through that public law to page 559, and you will see that it calls for our Armed Forces to be eliminated from NATIONAL CONTROL, which in turn wipes out our sovereignty as a nation. In the third state we shall

see a “zero military” and before stage one closes, all citizen-owned guns will be banned. This issue of national disarmament is now being discussed with world leaders, and the ban on certain defensive weapons here at home is not new at all, but part of a treasonous scheme to render America as a nation, and our citizens as individuals, helpless against the Socialist-Communist conquest of the world.

FINCEN is a global economic police force using INSLAW computer programs to track all financial transactions of every civilian. Clinton's phoney health care crisis is a cover to force a national I.D. card on every U.S. citizen, so you can be tracked by FINCEN.

To every concerned citizen of this country who can read and comprehend, these laws are in your County Law Library under Presidential Documents, U.N. treaties, Executive Orders, printed in the Federal Register, NAFTA, and soon to be GATT, the New Crime Bill, War Powers Act and State Department Bulletin 7277 which explains the complete disarmament of our military and private citizens.

## CHAPTER 12

### IN MORE WAYS THAN ONE FRAZZLED MOTHER EARTH IS *REALLY* HEATING UP

Many of you have felt that events in your world have been in a “holding pattern” of late and, to your perceptions, that would be an accurate assessment. However, know that it has been only your perception, for accurate and truthful information is not available to you through your mainstream media sources. Your world is in the process of heating up—in more ways than one.

Geologic activity is the subject you ones are wishing to hear of and many are wondering why I have been seemingly silent of late. There are times when it is of greater wisdom to say little. However, this day, I will address a few things in the area of geology.

Your planet, at this time, is in a state of heightened tension. This tension is demonstrated not only in the planet itself, but in its inhabitants as well. Those who are of an intuitive nature are sensing and feeling the presence of an extremely tense energy. Tempers are flaring, patience is wearing thin, and chiropractors are having to work extremely hard to keep their patients’ muscular structures in a relaxed state. Many are there who are complaining of severe headaches, backaches and the like. And, as the temperatures increase in the Northern Hemisphere, these symptoms are on the rise.

Your planet, likewise, is experiencing the very same things as are its inhabitants. For, once again, I shall be reminding you that you and your planet are on the same plane of experience, so your conscious state will be reflected in your planet. Her tension factor is running very high as well. But, as in the human, that tension can only be held for so long before it must be released.

The human will release that pent-up tension through bursts of anger and expressions of frustration. Heated words, arguments and physical confrontations are most common right now among you. The Earth’s equivalent of this will be such things as earthquakes, volcanic eruptions and severe weather patterns. These events are expressions of tension releasing; and, as with you, the planet can only hold this tension for so long, and then it will burst forth into physical manifestation.

These things, then, are the purpose of this writing. You see, the tension of your planet is most reflected once again in the Pacific Ocean area—that area you call the Ring of Fire. The name is most appropriate, for there is a great amount of volcanic activity which is taking place. However, up to this point, that activity has mostly been taking place **WITHIN THE DEPTHS OF THE OCEAN.**

You are entering into a time of danger from this volcanic activity—especially in Japan, the Philippines and the entire Indonesian area. New islands are in the process of being birthed due to this volcanic activity.

However, this birthing process is causing a disturbance throughout the entire area, and Japan, especially, sits in a most precarious position.

There are hundreds of volcanoes, all of which are still considered active, that are threatening at this very moment. The majority of these are beneath the water, but that does not represent safety by any means. As the magma finds its way upward from the inner depths of the planet, land masses are disturbed and will be caused to move with violent action. All the islands of the region were formed from just this type of geologic activity, and the building process continues to this day.

The Pacific Ocean area is the center of birth right now for your planet, as she continues to renew herself. Those who choose to reside there live continually in the shadow of destruction from seismic and volcanic activity. It has become a way of life, and many of the ancient cultures actually offered up sacrifices to the angry gods of the volcanoes, hoping to appease them and keep the flaming monsters from destroying them. Yet, the process continued, regardless of how many lives were thrown into the flaming pits—and, today, the threat still looms over the area.

This area has been rocking of late from seismic activity, with 6-point-plus earthquakes occurring regularly. You are hearing of only a few of these, and I shall not take the time to go into a detailed listing. **But know this: you are working your way up to several major seismic and/or volcanic events in that part of your world—and the threat is on the rise.**

Many of you who will read or hear this message are most concerned with the West Coast region of your United States. But, as you have been told before, it is most important that you pay very close attention to the Japanese Islands, for they will be your warning system.

There have been many earthquakes off the eastern coast of the main island of Japan in the past several days. These underwater quakes are a direct result of volcanic activity within the planet. It may not be apparent to you ones, but our devices are quite sophisticated and we have ability to “see” within the depths of the planet.

Likewise, you should also know that there is also activity on the eastern side of the Pacific Plate as well, with Chile and Peru, plus the Baja California region, experiencing NUMEROUS earthquakes in the range of 5 to 6 magnitude. And, just yesterday, there was a 5.6 earthquake in Alaska in the Unimak Island region. It was preceded by “little” “insignificant” 4.5 and 4.4 magnitude foreshock quakes.

You in California have been experiencing numerous small earthquakes, basically from stem to stern. **You are slowly working your way up to a major event and the most likely areas would be in the Los Angeles region and the San Francisco area.** Both are very riddled with numerous faults, and it is possible that one could cause the other to react. Los Angeles, especially, is threatened. (I shall not go into the who and the why—the political games and shenanigans are Commander Hatonn’s field of expertise. Mine is to merely report to you the state of geologic affairs. He may well have something to add to this in that respect.)

Just know that Los Angeles is a very hot spot right now for MANY reasons, and geologically it is NOT a good situation. It would not take much to throw that area into a state of complete devastation.



As I have said in the past, and now your scientists are finally catching up: the San Andreas Fault is not posing the greatest threat right now. Rather, it is all the little, inter-connected faults which run under the Los Angeles basin that you better keep an eye on.

“They” are right now concentrating heavily on the Elysian Park Fault [*named after the actual Elysian Park near Dodger Stadium*], and for good reason. There is a tremendous amount of energy potential there, but they would do well not to disregard the tributary faults that branch off it.

These “lesser” faults, as they have been tagged by your scientists, will most likely precipitate the conduction of seismic energy into the San Andreas Fault, so that it too will be showing signs of activity. The point of lock-up, so to speak, could be released by the smaller faults releasing their stored up energy.

Again, the best analogy for that area is a jig-saw puzzle and, when one part is moved, the entire puzzle is affected. There is little mystery as to how the fault systems operate; you ones are simply held in the dark. The only mystery is which one will go first. Even we cannot always tell that, for the inter-connectedness of the fault system is such that, though the highest energy potential may be at one point, sometimes it is but moments prior to an event that we see the energy bleeding off to another area, and it will be THAT point which will demonstrate surface movement that shakes you. The Earth has its own way of dealing with such things, and man can tamper and tinker all he wants, but the planet does not always react the way it is planned.

Yes, there have been numerous other earthquakes in many other areas, but with this writing, I am only going to address the Pacific Plate, for it is here we are most concerned with at this time.

**Many of you are sensing that something is about to occur somewhere in this large region, and that it is but a matter of time. You are absolutely correct in your feelings, and it is RIGHT NOW IMMINENT. We cannot say exactly where it will begin, but our information leads us to believe that it will be in the Japanese Island regions. That has the potential to release enough seismic energy to radiate around the entire Pacific Rim, and the weakest points will be the areas which will react to this radiation of energy. California, especially Los Angeles, is in a state of critical weakness, and it will not take much to cause major seismic activity there. It will, however, most likely occur in a series of earthquakes, each round building in magnitude and finally culminate in one massive event which will carry the potential of nearly total destruction for that area.**

Let me bring this to a close by saying that this next week coming up for your world is most crucial. There are many planned events that have the potential of creating havoc on many different fronts. These events may not be overtly evident, but know that they are taking place. Therefore, it would be advisable that you ones keep seeking for truth, for it shall be most elusive. ### PARASITES IN THE NEWS

No, not Henry Kissinger this time, but cryptosporidium. Although this parasite has been featured in other articles of late, this Reuters article from the June 16 issue of *THE ORLANDO SENTINEL* has a new twist, [quoting:]

ATLANTA—A potentially deadly parasite found in drinking water can be spread through sexual behavior, improperly prepared food, day-care centers and swimming pools, U.S. officials said Thursday. “We’re not sure which of these plays the larger role, but it seems that **water plays a relatively minor role** [*Disinformation?*],” said Dr. Dennis Juranek, who is with the parasitic diseases division of the U.S. Centers for Disease Control and Prevention.

The parasite, which eludes water treatment systems that meet current Environmental Protection Agency standards, contributed to 100 deaths and 400,000 illness in Milwaukee in 1993. [*Keep in mind that this parasite is one chosen as a carrier for the Elite’s deadly designer diseases.*]

### WORST DESTROYERS OF HUMAN LIFE

That’s the headline—referring to parasites—in an article by Brian Moore in the June 19-25 issue of the *WASHINGTON TIMES, NATIONAL WEEKLY EDITION*, [quoting:]

While HIV infection and the Ebola virus get headlines, the big destroyer of human life and dreams of achievement is intestinal worms. According to a recent World Health Organization report, more than 1.5 billion human beings are afflicted with multiple intestinal parasites; in 1994, 16.5 million people died of infectious or parasitic diseases, roughly one-third of all the world’s deaths that year.

In the human body, these worms compete with their host for hard-won food, suck blood, cause anemia and stunt physical and mental growth. [*Does this sound familiar?—reminds me of Eustace Mullins’ book, The Biological Jew.*]

### BEWARE DENGUE HEMORRHAGIC FEVER

More disease outbreaks—this one is from the June 17 issue of *THE ORLANDO SENTINEL*, [quoting:]

GENEVA—Hard on the heels of an outbreak of the deadly Ebola virus in Zaire, the World Health Organization sounded the alarm Friday about a similar type of disease spread by mosquitoes. There are hundreds of thousands of cases of dengue hemorrhagic fever each year, and the disease is on the increase, the U.N. agency said. Although less deadly than Ebola, in which victims literally bleed to death, dengue hemorrhagic fever also causes high fever, vomiting and bleeding. Transmitted by mosquitoes, it spreads far

more easily [*i.e., more efficient for depopulation purposes*] than Ebola, which requires contact with bodily fluids.

### AIDS MISINFORMATION IN D.C.

WASHINGTON—Protesters chanting, “shame, shame,” festooned the iron fence of the White House with at least 75 rubber gloves Sunday afternoon. The action came five days after several uniformed White House police officers greeted a delegation of about 40 gay and lesbian elected officials wearing rubber gloves. They claimed they were for their “protection”.

The officers, who are members of the uniformed division of the Secret Service, wore the gloves as they searched the possessions of the gay delegation prior to admitting them to the White House grounds. Although the police officers apparently feared that some of the delegates might have AIDS, medical authorities say the disease cannot be spread by casual contact. [*Sounds like the Secret Service knows better than to believe AMA propaganda about AIDS and casual contact. However, according to the book AIDS: Secrets, Lies, and Myths EXPOSED (see page 27), rubber gloves—and condoms—are an ineffective barrier to the tiny AIDS virus, which can easily pass through the pores (“like shooting a BB gun through a tennis net”). This information is conveniently suppressed to keep us ignorant—and easier deaded!*]

### WEAK AIDS/STRONG AIDS

More disinformation on AIDS, this from an AP article in the June 16 issue of the *ROSWELL* (N.M.) *DAILY RECORD*, [quoting:]

A weak type of the AIDS virus may teach the body to protect itself against the more virulent and lethal form of the disease, researchers concluded after studying infections among prostitutes in Africa. [*Uh-oh—a glitch in the Elite’s plans for depopulating the globe?*] Dr. Phyllis Kanki, a scientist at the Harvard School of Public Health, said a nine-year study in Senegal showed that prostitutes infected with HIV-2, a weak type of the AIDS virus, had about a 70 percent less likelihood of acquiring HIV-1, the aggressive virus that causes most of the world’s AIDS deaths. “Our study suggests that maybe this related virus can tell us how we can make a vaccine that will create immunity against HIV-1,” Kanki said in an interview. She said it was this relationship between a wimpy virus and a more lethal first cousin that led to the defeat of small-pox. HIV-2 can cause AIDS, but it is much less aggressive and much less virulent, she said. It can take up to 25 years for people infected with HIV-2 to develop AIDS, while HIV-1 is lethal in about half that time. [*Since AIDS was all but unknown 25 years ago, I wonder how she could legitimately know that? Anyway, a virus that takes **longer** to kill you doesn’t sound like a great idea for a vaccine, especially considering the fact that all the various AIDS viruses are recombinant retroviruses, meaning they have the ability to recombine with the genes of any cell they enter, creating new forms of the parent virus. And, does it make sense to entrust the cure for AIDS to the same people who may have created it?*]

### “FINANCIALLY HEALTHY QUACKS PREY ON DESPERATE AIDS PATIENTS”

Of all the articles received this week, this one was the most annoying. It's chock full of unsubstantiated put-downs and trigger words—propaganda designed to ensure that the people succumb to the Elite's plans for worldwide depopulation. This AP article is from the June 18 issue of *THE ORLANDO SENTINEL*, [quoting:]

Mexican herb extracts and hydrogen peroxide shots are among the **bogus** cures being touted by **phony** doctors.

Robert McCoy, curator of the Museum of Questionable Medical Devices in Minneapolis, recently spoke to about 125 physicians, nurses and other health professionals at a University of Pittsburgh conference on alternative AIDS and cancer treatments. He and other speakers warned that **quack** devices and **whacked-out** cures are increasingly being offered to AIDS patients. "This is out-and-out quackery using **inappropriate** diagnostic techniques and **inappropriate** treatment. And they are doing it for one reason—money," he said. [*Evidently a projection on his part, since he would have no way of knowing the intent of so many people he has never met.*]

[*John K. Renner of the National Council Against Health Fraud said:*] The **counterfeit** cures interfere with **legitimate** [*i.e., politically correct according to the AMA-Elite*] therapy, disrupt research and divert precious patient **money** [*from AMA pockets*]. The physician said he often visits alternative health fairs in disguise to assess **quackery** [*Note that the writer has just equated "alternative health fairs" with "quackery".*] The researcher was critical of macrobiotic diets, vitamins, and other nutritional treatments.

Often **quacks** encourage patients to abandon reason and rely on "magical thinking", he [McCoy] said. [*The pot calls the kettle black! "Volunteering creates a mentality that is certainly a lot healthier for society..." To teach teens about the virtues of community service, public school districts in about two dozen states now **require** students to perform community service work in order to graduate. And Maryland has made **voluntary service** a statewide **requirement** for high-school graduation. [*Huh? I think they're playing with our minds again!*]

#### "ANTI-SEMITISM" IN CANADA

I have yet to see a mainstream paper that does not DAILY feature some item of propaganda about the holocaust and anti-semitism. It may be in the cooking section, film reviews, sports—but it's always there—

## CHAPTER 14

### FEMA TAKES OVER RESERVE FORCES

*Editor's note: The following warning is from page 14 of the July 3, 1995 issue of SPOTLIGHT.*

#### **A “helpful” federal agency now has its own army for use “internally or externally”.**

The U.S. Army Reserve Command (USARC) will be totally integrated into a new plan by September 1996, which will relegate it to control by the Federal Emergency Management Agency (FEMA). FEMA was established under President Jimmy Carter, by executive order, to have virtual dictatorial powers over the people of the United States during any “national emergency”, as declared by the president.

During the early days of the Clinton Administration the plan was altered somewhat to place FEMA under the control of the National Security Council and the president's national security adviser, a post currently held by Anthony Lake.

According to headquarters of USARC, the plan will reorganize its structure “in a move that will enhance its ability to support domestic missions and improve its readiness to go to war.

“An important feature of the plan is that it will permit the Army Reserve to provide greatly enhanced federal military support to civilian authorities and other federal agencies for domestic assistance missions. The Regional Support Command boundaries coincide with the Standard Federal Region (SFR) boundaries used by all federal agencies, including the Federal Emergency Management Agency.”

According to documents obtained from Army Reserve sources in Texas, the following explanation of the new Regional Support Commands, under FEMA, was provided to reservists as follows:

“You may have heard the expression that once a railroad train comes through your living room, it will never be the same again. A train has passed through the living room of the U.S. Army Reserve structure and it will never be the same again.”

In a Texas reserves briefing paper describing the “impact” of the new alignment, it was stated “reservists will become to FEMA what National Guardsmen are to state governors.” In other words, the reserves will serve at the direction of FEMA, as the National Guards of the various states are supposed to serve at the direction of the governors.



In what appears to be an indication of dissension within the Army Reserve, at least in Texas, individual reservists have been advised to “Pay close attention to what you hear in the next few months. Position yourself to take advantage of opportunities as they arise. Only you can decide if the new Army Reserves will be compatible with the goals you have set for yourself.”

According to an explanation of the realignment reported by the headquarters of USARC, under the new plan 20 U.S. Army Reserve Commands (ARCOMs) will now be reporting directly to ARCOM headquarters, and three Regional Support Groups (RSGs) will report to the Regional Support Commands, configured within the ten FEMA boundaries.

From its strength of 319,000 soldiers in 1989, the Army Reserves will be reduced to 208,000 by 1998. Sources in Texas told *The Spotlight* there has already been an announced reduction of 20,000 combat ready reserve troops and an additional 50,000 combat ready reservists will soon be added to the “hit list”.

According to ARCOM headquarters, the plan is “aimed to transform the Army Reserve, not into a smaller version of the Cold War force, but into a new Army Reserve, able to provide fully ready units for America’s Army of the next century and to provide a greatly enhanced capability *in support of domestic actions* [SPOTLIGHT emphasis]...FEMA Regions are also Standard Federal Region boundaries. All federal agencies use these boundaries except for DOD [Department of Defense].

“This alignment allows the USAR to use our combat support and combat service capabilities to support domestic missions and add intrinsic value to the Administration’s domestic agenda...”

According to Army Reserve sources in Texas, the reorganized reserves “*will give the nation a new level of capabilities for Military Support to Civilian Authorities. By establishing regionally based and focused assets to compliment existing structures, FEMA will have regional planners and managers to assist in domestic support missions* [SPOTLIGHT emphasis]. *The plan aligns the Army Reserve with current administration commitment for an Army that can address this country’s needs both externally and internally in the form of domestic support when called upon...*” v

## CHAPTER 15

### FEAR OF FAUCETS

#### MORE THAN JUST “STOMACH FLU”

In order for the viruses in tap water to sicken water-drinkers, they must pass through the stomach’s corrosive acid environment. Only a few dozen intrepid viruses have evolved that have the ability to survive the journey. **[H: Of course with the pushing of antacids you have provided a nice comfortable rest-bed for the little varmints, removing all difficulty in survival and allowing passage undaunted right on out through the intestinal system and directly back into your drinking water after a nice vacation journey—unless of course, they have to stop and multiply and divide in some loving host body—then bunches more are provided into the water supply of loving friends and neighbors every time you “flush”.]** These survivor viruses, however, are worrying epidemiologists because they’re increasingly linked to serious, disabling human diseases.

As a group they’re known as enteroviruses and they can cause disease from mild queasiness to killing heart failure. Because the outer coat they evolved to protect themselves from stomach acid also helps protect them against chlorine, the most common chemical used to disinfect tap water, enteroviruses are a significant source of waterborne disease. To finish off some enteroviruses may take hundreds, even thousands of times more chlorine, and much more time than it takes to kill ordinary bacteria.

These hardy enteroviruses may be the most dangerous life forms surviving modern water treatment. That’s disturbing, because current research is linking some of the 73 known human enteroviruses (Poliovirus, Coxsackie virus, Calicivirus, Echovirus, Rotavirus, Norwalk virus, Hepatitis) to long-term, serious illnesses. The most compelling evidence implicates Coxsackie virus, linked to a devastating form of heart disease in which the heart becomes enlarged, flabby and weakened—dilated cardiomyopathy, currently the chief cause of heart transplantation. The virus seems to trigger a post-infectious autoimmune disease that can eventually result in heart damage and death.

***These findings aren’t just important to ivory-tower researchers: More than half of all people receiving heart transplantation originally became sickened by viral infection of Coxsackie virus.***

“For some of these viruses, years may pass between initial exposure and symptoms,” said Rose. That long duration makes it easy to understand why it’s been extremely difficult for scientists to link, say a flu-like illness one day with serious disease months or years later. The true frequency and origins of many enterovirus infections, masked until now, remain to be discovered.

Consumers concerned about possible microbial contamination of their drinking water have a number of options. *(Editor’s note: Please appreciate how NONE of these suggestions are effective against viruses.)*

- \* Have your water tested. Many independent laboratories will test for toxins and bacteria.
- \* If you have a carbon filter, change the carbon at least as frequently as the manufacturer suggests.
- \* In the morning run the water for at least half a minute before taking a drink.
- \* Be certain that all faucets to which garden hoses are attached are fitted with an anti-siphon device to prevent a reverse flow from hose to indoor plumbing.
- \* Call the local water utility and get a free copy of its latest water quality report. The report will list levels of coliform bacteria and chemical pollutants found in tap-water samples. The utility engineers may also be able to provide you with a rough idea of the coliform count in source water. If the number is above about 10,000 total coliforms per liter, the source water is roughly as contaminated as that in Payment's experiments.
- \* If you decide to buy a home water-treatment unit, an excellent reference is the January 1990 *Consumer Reports* magazine *Fit to Drink* article.
- \* Don't confuse distilled water with sterile water. Distilled water is not chlorinated and has been shown to be frequently contaminated with bacteria.
- \* Bottled water may be purer than tap water, but some city-manufactured bottled waters may contain more bacteria than plain tap water. Other bottled waters may be a better bet—if you can determine your local brand's water source.
- \* For additional information, consult the EPA's Safe Drinking Water Hotline at (800) 426-4791, from 8:30 a.m. to 5 p.m. EST. [END OF QUOTING.]

#### A FILTER THAT BREEDS BACTERIA

*(Editor's note: The following is the second of two auxiliary articles to the main FEAR OF FAUCETS story on water contamination.)* [QUOTING:]

Consumers who have bought or who have been considering buying reverse osmosis filters might want to know that Pierre Payment recently discovered an unexpected bacterial problem with many of them. Designed to remove bacteria from tap water, they can also breed it—in staggering quantities.

Under-the-sink reverse-osmosis filters usually pass water first through a carbon filter to remove chlorine and other chemicals and then through a membrane that excludes everything but pure water. Since the membrane filters water at a rate of one gallon every three to six hours, the water is usually stored in a two-gallon holding tank under the sink until it's needed. That's the problem.

The water in the tank has been stripped of the residual chlorine that water plants add to stop bacterial growth in pipes. Sitting stagnate at room temperature often for days in the tank is an ideal breeding ground

for bacteria. And breed they do. Payment measured an average of 10,000 bacteria per milliliter of tank water—20 times more than average tap water, some units breed up to 10 million bacteria per milliliter. “Those consumers were drinking water that contained more bacteria than milk,” says Payment.

“I was surprised,” the Canadian virologist remembered. He discovered that once a filter grows bacteria, it would continue growing them in about the same numbers for months. He published his findings in the April 1991 issue of *Applied and Environmental Microbiology*.

“The bacteria growing in the filter weren’t ones we see too often,” he says. His team grew the bacteria in the lab, and watched as beige, yellow and sometimes pinkish splotches spread across their petri dishes. The main species—*pseudomonas acinetobacter*, *fiavobacterium*, *alcaligenes moruxella*—were known to other researchers and **presumed** harmless.

Payment’s statistics suggested otherwise. People drinking water from filters contaminated with fewer than 1,000 bacteria per milliliter are known to be coming down with gastroenteritis—about what you would expect from the normal population. But a third of the filters grew microbe-laden water with 100,000 or more bacteria per milliliter. People who drank that water, Payment found, averaged five bouts of gastroenteritis each year—10 times what people drinking unfiltered tap water experienced. **Their \$1,000 filter had given them diarrhea rates like those in the Third World.**

If it weren’t for these extra filter-bred illnesses, **Payment’s Montreal experiment might have shown even greater differences in illness between the filtered and unfiltered groups—more like 35 or 40 percent.** If he can ever conduct a repeat test with biologically pure water—a technical challenge—he may be able to pin down the exact level of sickness that tap water can produce.

The Quebec researchers have stumbled onto a major regulatory oversight—home water treatment devices are barely regulated by the government. “The major problem is that nobody tests the filters microbiologically once they are installed,” says Payment. They’re installed and then forgotten. The salesman says, “change the filter every six months, and that’s it.”

The \$100 million home reverse-osmosis filter industry has more than doubled since 1985.

“We’ve seen research that the human body is fully capable of tolerating higher amounts of bacteria,” counters Peter Censky, executive director of the Chicago-based Water Quality Association, representing 2,600 manufacturers/services of water treatment devices. “Empirically, you consume much more bacteria from your table, your face, your skin. But the question is still open because we don’t know enough about the physiology of drinking water.”

Last December, Congress’ General Accounting Office was far more critical of home water treatment units. “No single authority,” the GAO reported, “exists to ensure that units perform as sales agents claim.” **[H: Now, if you believe the GAO would “help” you by more regulations then I do have another bridge to sell you in New York.]** Calling federal regulation of the units “fragmented and incomplete”, the GAO recommended that the Consumer Product Safety Commission, the Federal Trade Commission, the EPA and industry coordinate a strategy to regulate the effectiveness and safety of the home units. **[H: Oh boy, that should insure that no one ever gets safe water again in a lifetime.]**

Certainly units like the one used in Quebec are in dire need of regulation. Though about 600 manufacturers make home water treatment units, only 54 to date have gotten around to having the Water Quality Association certify their units. Ironically, even that certification (the “Prestigious Gold Seal” in association literature) fails to test reverse-osmosis units for bacterial contamination.

Instead, the Gold Seal is earned if the unit merely filters out dissolved solids, doesn’t leak under pressure and isn’t composed of toxic materials. Water Quality Association literature—while stressing that these units can filter tap water bacteria—never mention that the filters often produce water containing up to 100,000 times more bacteria than the incoming tap water.

Payment’s 1991 research paper on the filters concluded: “These observations raise concerns for the possibility of increased disease associated with certain point-of-use treatment devices for domestic use when high levels of bacterial growth occur.”

“We want to repeat Pierre’s study,” said microbiologist Marc LeChevallier, senior research microbiologist with the industry’s American Water Works Service Company. “Reverse-osmosis is a good system—just the way it’s implemented may need to be modified. You’ve got to recirculate that water to keep it from sitting stagnant.” [END OF QUOTING.]

### DRUGGED IN COLUMBIA: STREET THUGS DOPE UNWITTING VICTIMS

From the July 3 issue of the *WALL STREET JOURNAL*, [quoting:]

BOGOTA, Columbia—If you thought cocaine was bad news, wait until you hear about Burundanga. Burundanga is a kind of Colombian voodoo powder obtained from a common local plant of the nightshade family, a shrub called borrachera, or “drunken binge”. Used for hundreds of years by Native Americans in religious ceremonies, the powder when ingested causes victims to lose their will and memory, sometimes for days. [*Sounds made-to-order for MK-ULTRA Monarch Mind-Control projects.*] In Columbia, the drug’s most avid fans are street criminals. Crooks mix the powder with sedatives and feed the Burundanga cocktail to unsuspecting victims whom they then proceed to rob—or worse. Doctors here estimate that Colombian hustlers slip the odorless, colorless and soluble Burundanga in food or drink to about 500 unwittingly victims in the city each month. “The victim can’t say no; he has no will and becomes very open to suggestion. It’s like a chemical hypnotism,” says Dr. Camilo Uribe [*who runs the city’s foremost toxicology clinic*]. “From the moment it’s given, the victim remembers absolutely nothing of what happened.” Not all cases of Burundanga involve theft or robbery. Sometimes, victims have been used as mules to carry cocaine [*Or blow up buildings?*], says Dr. Uribe’s brother Manuel, a neurologist practicing at the clinic.

### DRUG-BUST BOOTY SHARED WITH ISRAEL

From the June 28 issue of *THE ORLANDO SENTINEL*, [quoting:]

BOSTON—U.S. officials on Tuesday shared with Israeli government the proceeds from assets seized from drug traffickers. The U.S. attorney in Boston, Donald Stern, presented a check for nearly \$35,000 to Israel’s consul-general, Asher Yarden. The traffickers were captured with the help of the Israeli national police and it is thought to be the first time such confiscated assets have been shared out between governments. [*Another U.S.-Israel first, and how ironic, since the Israeli Mossad is pivotal to the international drug trade.*] The funds came from the sale of assets seized from an international drug ring led by Israeli national Shmuel David. Sixteen members of the gang were convicted in 1989 of distributing hundreds of pounds of cocaine in the Boston area.

### WORLDWIDE DEMAND FOR ISRAELI “SECURITY FIRMS”

From an Associated Press article in the June 25 issue of the *ALBUQUERQUE JOURNAL*, [quoting:]



When some of the world's most powerful, most famous and most notorious people want their security guaranteed, they hire Israeli firms. Although no exact numbers are available, one defense expert, speaking on condition of anonymity, said some 4,000 Israeli companies [*i.e.*, *Mossad-affiliates*] are active in the security field. And that number is rising. The firms need Defense Ministry approval to sell weapons and make training contracts overseas, but modern communications and a global marketplace have made enforcing the restrictions difficult. While private security firms are often secretive about their activities, questionable or illegal deals are sometimes exposed. Yair Klein, a lieutenant colonel in the army reserves who used to run a private security firm, was convicted in 1990 of illegally selling weapons and military expertise abroad. [*Like Oliver North, he is now, no doubt, a popular Israeli talk show host!*] Colombian officials charged at the time that Klein was arming and training Colombian drug traffickers. He has denied the charges. He was fined \$40,000 by the Israeli court and runs a chicken restaurant in Tel Aviv. [*Well, I wasn't too far off!*]

Last year, Israeli mercenaries were revealed to be training soldiers in the West African nation of Zaire [*For whom?*] in a multi-million dollar deal. According to other reports, former Mossad operative **Mike Harari** several years ago obtained weapons systems and bugging devices for Panama's president, Manuel Noriega. [*Michael Harari—his name turned up in Michael Maholy's CIA Pipeline series (in CONTACT) as a link in illegal international drug and weapon trade, as well as a Mossad officer (code named "Cobra") and teacher of torture techniques in Victor Ostrovsky's Mossad exposé, By Way Of Deception.*]

#### LUBAVICHER RABBI RECEIVES CONGRESSIONAL GOLD MEDAL

This article appeared in the June 27 issue of the *NEW YORK TIMES*, [quoting:]

Rabbi Menachem Mendel Schneerson, the leader of the Brooklyn-based Lubavitch movement who died a year ago at age 92, will be awarded the Congressional Gold Medal in Washington tomorrow. [*According to this article, the medal was sponsored by that alleged-conservative darling of the media, **Newt Gingrich**, and others and approved by Congress last year. This same rabbi was the focus of Public Law 102-14, which has become known as the Noahide Law and forerunner of the New World Religion, which, in effect, puts U.S. citizens under the Jewish Talmudic Noahide Laws. Rabbi Schneerson and Public Law 102-14 are discussed in Phoenix Journal #88, ADVANCED DEMOLITION LEGION (THE ADL IN ACTION). And what happened to the old "liberal" battle cry: "separation of church and state"?*]

#### PERSIAN GULF SYNDROME: THE TRUTH AT LAST

This excellent article by Alan Cantwell, Jr., M.D., comes from a recent issue of the *STEAMSHOVEL PRESS* (P.O. Box 23715, St. Louis, MO 63121). Here is a brief excerpt, [quoting:]

In the search for a cause of the syndrome, epidemiologists have been searching for a common factor that could have exposed everyone stationed in the Gulf. Some sick vets were in the war zone for months, while other ill vets served in the Gulf for as little as nine days! And the disease has affected troops who were

stationed in widely scattered geographic areas in the Gulf.

As early as December 1990, there were warnings against experimenting with U.S. troops. There was great concern about the decision of the FDA to allow the Pentagon to use unapproved experimental drugs and vaccines on soldiers without their consent. Furthermore, the Pentagon refused to identify the types or the numbers of drugs and injections that they intended to prescribe.

An angry soldier stationed in Saudi Arabia sued the government in January 1991 over the issue. Ever since the Nuremberg trials, which convicted many top-ranking Nazis for crimes against human nature, it has been considered unethical and unlawful to use people as guinea pigs in medical experiments without their informed consent. This ethical requirement was waived when the soldier's lawsuit was dismissed by U.S. District Judge Stanley S. Harris. The judge cited the necessity of the military to protect the health of its troops; the fact that the vaccines and drugs were untested and unapproved by the FDA was deemed irrelevant. Soldiers who refused injections were given them forcibly.

The military has a long history of conducting covert medical experiments on its own personnel, as well as on civilians. Dozens of secret, planned bioattacks were perpetrated on American cities during the 1950s and 1960s, the most notorious being a six-day bioattack on San Francisco in which the military sprayed massive clouds of potentially harmful bacteria over the entire city. Physicians play a crucial role in covert and unethical experimentation, as chronicled by Gordon Thomas, author of *Journey into Madness: The True Story of Secret CIA Mind Control and Medical Abuse* (1989).

Vaccines can be hazardous. In WWII, more than 50,000 cases of hepatitis were caused when troops were injected with yellow fever vaccine unknowingly [??] contaminated with human blood serum containing infectious hepatitis B virus. Even the mandated "DPT" shot routinely given to babies has known risks...If serious consequences of compulsory "routine" and "approved" vaccines are freely admitted, what are the health consequences of unapproved, untested and experimental vaccines?

Experimental and non-experimental inoculation programs can be a surreptitious way of "introducing" harmful infectious agents into unsuspecting people. [*And numerous examples are given.*] Is the Persian Gulf Syndrome another AIDS Holocaust in the making? Like AIDS, the disease can be traced back to human experiments with untested and unapproved vaccines. Like AIDS, the Gulf syndrome appears to be transmissible through sexual activity, and can be passed on to children. Like AIDS, the vets' disease affects the immune system. Like AIDS, there is no cure. [*At least, no cure that will be made available to us.*]

WASHINGTON, D.C.  
(DETERIORATING CITY)

This Associated Press article is from the July 2 issue of *THE ORLANDO SENTINEL*, [quoting:]

The busses rumble up to the Washington Monument, one after another, discharging respectful Americans onto a green and ordered landscape. They have come to see their capital, reflecting the best of what their nation can be. What they see is spectacular. But the Washington they don't see is an affront to America's ideals.

This is Washington, D. C., in 1995:

- \* The police chief resigned, saying things were so bad that some officers couldn't file search warrants because they had run out of the proper forms.
- \* Department of Public Works crews were reduced until only six workers were left to cut city-owned grass. Near the U.S. Soldiers' and Airmen's Home, weeds stand 5 feet high.
- \* A study found 42 percent of the city's black male population in prison or jail, on probation or parole or being sought.
- \* Schools began late because of fire code violations and closed early to save money.
- \* Four of the city's 15 dilapidated health clinics were closed due to lack of money at a time when the AIDS virus is spreading more quickly in Washington than any other major U.S. city.

Crime has declined recently, but drugs and lawlessness still rule many neighborhoods. In a recent five-month period, about 1500 teenagers were arrested for crimes ranging from homicide to car theft, causing the City Council to vote to impose a youth curfew. Even the mayor has a criminal record. Marion Barry was recently returned to office after a four-year hiatus, some of which was spent in prison on drug charges.

"There's a cultural element to this," Sam Smith, editor of a muckraking local newsletter. "We're a town of bureaucrats, and it will curse us evermore." [*Which is one reason why Commander Hatonn's advice to form a collateral government with a **different** capital city makes so much sense.*]

COURT RULES, WE LOSE

From the June 30 issue of *THE ORLANDO SENTINEL*, [quoting:]

In one of the most important environmental cases in a generation, the Supreme Court on Thursday affirmed the government's broad authority to require private landowners to protect the habitat of endangered wildlife.

The court ruled 6-3 that the U.S Fish and Wildlife Service has not exceeded the intent [*Yeah! This was the intent all along!*] of the 1973 Endangered Species Act by prohibiting the modification or destruction of wildlife habitat on private land in order to protect threatened and endangered species from harm. Ruling

in a dispute from Oregon over protection of the northern spotted owl, the court said the 1973 law provides “comprehensive protection for endangered and threatened species”, and the government’s interpretation that such protection includes habitat is reasonable. The decision is a big victory for environmentalists and a setback for the timber industry and property-rights advocates.

Both sides agree the Endangered Species Act outlaws direct hunting, trapping, or killing of endangered and threatened species of animals. They also agree the law bans destruction of a protected species’ habitat on federal land. But they went to court over the law’s application to protect habitats located on private property.

A congressional report said 90 percent of the 781 endangered or threatened species listed by the government in 1993 have habitats on privately owned land. With the ruling, federal regulators can require species-friendly development restrictions on millions of acres of beach front, farms, and forest if they can prove losing the privately owned land would harm the animal. [*If the government can tax or restrict it, you don’t really own it, do you?*]

#### “GOOSE SENSE”

**This** spring when you see geese heading back north for the summer, flying along in a V-formation, you might be interested to know what scientists have learned about why they fly that way. It has been learned that as each bird flaps its wings it creates an uplift for the bird immediately following. By flying in a V-formation the whole flock adds at least 71% greater flying range than if each bird flew on its own. *Basic Truth #1: People who share a common direction and a sense of communication get where they are going quicker and easier because they are traveling on the trust of one another.*

Whenever a goose falls out of formation it suddenly feels the drag and resistance of trying to go it alone and quickly gets back into formation to take advantage of the lifting power of the birds immediately in front. *Basic Truth #2: If we have as much sense as a goose we will stay in formation with those who are headed the same way we are going.*

When the lead goose gets tired, it rotates to the back and another goose flies the point. *Basic Truth #3: It pays to take turns doing hard jobs, with geese flying north or with people.*

The geese honk from behind to encourage those up front to keep up their speed. *Basic Truth #4: We need to be careful what we say when we honk from behind.*

Finally, when a goose gets sick or is wounded by gunshot or falls out, two geese fall out of formation and follow it down to help and protect it. They stay with that goose until it is able to fly or until it is dead, then they launch out on their own or with another formation to catch up with their group. *Basic Truth #5: IF WE HAVE THE SENSE OF A GOOSE WE WILL STAND BY ONE ANOTHER!*

*CONTACT* readers will remember our issue of July 19, 1994 devoted in large part to concerns of the Hopi Tribe. These concerns included: violation of sacred Hopi lands by bulldozers poised to lay the groundwork for water and power lines thus fulfilling and perhaps triggering the "Great Purification" according to Hopi Prophecy; the pumping-down of the aquifer beneath the Hopi lands by the huge Peabody Coal Company, thus affecting springs and the water table under Hopi property; and a Call to Mankind to Return to Peaceful Ways.

Since then there have been many developments, a summary of which we will share with you in the form of a letter received here at *CONTACT*. Craig Carpenter, a Mohawk, is discussed in numerous books, including God's Chosen People of America, Billy Jack, The Occult Explosion, The Healing Voice, Book of Elders, and Peter Matthiessen's book titled Indian Country.

In Matthiessen's book, Craig's background leading to his role as a "messenger" is thoroughly explored, including his journey to Navajo and Hopi lands. A messenger is one who is charged to uphold the Hopi message and promote the Hopi teachings. Craig has traveled internationally for Hopi elders carrying their message of peace since 1954. [Quoting:]

Dear Editor, Subscribers and Supporters of *CONTACT*,

I have heard from several sympathizers and fellow-workers that you published, and constructively responded to, the *Call for Action* from Hotevilla Village in Hopiland in the Spring of 1994. I want to here and now express my gratitude to you, and to each of you, and to your Aumakua ("Unseen Helpers from the Lowest to the Highest") for that literally life-saving co-operation.

The stopping of the installation of water lines and sewer lines at that time was indefinitely postponed, I was informed, until AFTER the Arizona Public Service (Power Company) could complete its attack on Hotevilla by installing utility poles and electric power lines into Hotevilla in early January of 1995.

The 1,000 or more letter, faxes, telegrams and telephone messages which *CONTACT* helped inspire and motivate in support of JUSTICE for Hopi DID stop the completion of the proposed sewer lines and water lines in 1994; but over 18,000 similar protests in January of 1995 to A.P.S. and to the so-called "Hopi", so-called "Tribal", so-called "Council" did NOT stop the installation of electricity into Hotevilla. How-



ever, the projected completion of Water Lines and Sewer Lines by the U.S. Indian Health Service, and the \$3 million contract by U.S. Environmental Protection Agency to pave the streets of Hotevilla “...within a month...” of the completion of those electrical terminals has not yet materialized, some 6 months later.

Since a whole new chain of historical information and legal information came to our attention as a result of this latest Battle with The Beast, and since that historical and legal information may also be of benefit to you and to your People (Nation) in our united “Stand” for This Land and Life, as articulated in the Just and Humanitarian Principles of the *Constitution of the United States of America*, I am enclosing samples of some of the exchanges of dialog and reasonings which occurred during the recent confrontation of Hotevilla. These dialogs include the 5 basic introductions to the historical and legal informations mentioned above.

IF any of the enclosed introductory materials are of interest to you and/or if I can be of further assistance to you, please let me know—and at ANY hour of the day or night. Thank you, and Aloha!

*The most recent news coming from Hopiland concerns the eviction of a non-Hopi man, Roy Steevensz, from the Titus Farm. Quoting the initial press release received by CONTACT on this matter signed by and from: Rena Murillo, Emery Holmes, Mildred Holmes, Brian Holmes, Emery Holmes, Jr., Verbina Murillo, “On June 22 of 1995 at approximately 4:30 p.m., twelve Bureau of Indian Affairs Police cars under the direction of the illegally-created Hopi Tribal Council entered the Sovereign Lands of Titus’s Farm and arrested Roy Steevensz, a friend of the Traditional Hopi. Mr. Steevensz was charged with ‘Criminal Trespassing’ and was taken off the Hopi Reservation...*

*“The Tribal Police entered Titus’s Farm without a Search Warrant, drove over a planted corn field, kicked in and destroyed the door, and arrested Mr. Steevensz at gunpoint. Two other men present were pushed onto the ground, also at gunpoint, and ordered to sit on the ground or else they would also be arrested.*

*“It is unlawful and un-Hopi to use any form of gun or militant force, and to destroy corn and property. Rena Murillo will file criminal charges against the Hopi Tribal Council Chairman, Ferrell Sekacucu, for reparations.*

*“The Tribal Council has no legal jurisdiction over Titus’s Farm or any portion of Hotevilla. ‘Legally’ created by the United States Government in 1934, the Hopi Tribal Council is the only voice the U.S. Government will recognize. The Traditional Hopi Elders have lost their Voices, their Lands, and now their Freedoms. Mr. Steevensz has been a supporter of Hopi Spiritual Elders and a counselor on nutrition and has their full support to remain on Titus’s Farm.”*

*CONTACT is in receipt of legal documents from the Office of the Chairman of The Hopi Tribe. These documents include an Automatic Judicial Removal Order (signed by the Judge of the Hopi Tribal Court); and a Hopi Tribe Decision and Order in the Matter of the Proposed Order of Exclusion of Roy Steevensz (signed by Chairman Secakuku). According to these documents, Mr. Steevensz*



*had been residing on a closed portion of the Hopi Indian Reservation without a permit in violation of Hopi Tribal Ordinance #46.*

*After carefully reviewing all of the information on the eviction of Mr. Steevensz, it certainly appears that the actions taking place concerning this matter are entirely legal. Whether they are “lawful” or “right” are matters which must always be addressed within the context of whatever political structure is in place. As with many of the Constitutional arguments so prevalent among “patriots” today, you can argue “Constitutional” until you are blue in the face—but if, in the end, they take you off to prison, what constructive purpose has been served? Is it not more appropriate to work with what “IS”?*

*Regular readers of CONTACT are well acquainted with an entire spectrum of injustices prevalent in our society today. If staying on Titus’s Farm requires a permit under Tribal statute, why not get the permit? If, then, eviction is ordained, it becomes abundantly clear that the permit was not the real issue.*

*And, if the issues at hand are truly with the Hopi Tribal Council, then deal with the issue of the Hopi Tribal Council directly by whatever legal means are available.*

*But, I must add here, this is AN INTERNAL HOPI AFFAIR.*

*In a later letter to CONTACT from Craig Carpenter dated July 3, “...if you want to find out if what you have read, or heard, about the Hopi is true or not, you must go to the Hopi and find out. But of the perhaps 20,000 people who claim to be Hopi, or who are “recognized” as Hopi by Uncle Slam [author’s spelling], the ones I consider to be genuine Hopi I can count on the fingers of one hand, maybe two. So, ‘beware the wolves who are disguised as sheep,’ they can talk more convincingly than the genuine sheep BUT THEIR ACTIONS BELIE THEIR WORDS.”*

*For those interested in following the Steevensz eviction, the Preliminary Hearing is continued until July 20 at 1:00 P.M. at the courthouse in Winslow, Arizona. (However, most of you will have received this issue after that date.) At the present time, Steevensz has neither legal counsel nor the funds to obtain that representation.*

*In a Hotevilla Village Board of Directors’ statement from January 1994, they asked for non-interference and that media only reflect the truths in these situations and not sensationalize.*

*CONTACT, as our readers know, is devoted to TRUTH. It would be my sincere hope that even the Hopi Elders would come to know that when a call for help is put forth from their quarter, it will reach the ears of the other Bird Tribes and it will be heard and spread from this quarter—and the call going forth via THE PHOENIX can often help them in ways that perhaps have not been considered up to this point. I only mention this so that possibilities not be excluded amidst rigid thinking. There are allies around the globe—and in the spirit of the Golden Rule—God Grant Us The Wisdom To Recognize Them.*
